A BILL FOR AN ACT

RELATING TO THE HAWAII TEACHER STANDARDS BOARD SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 302A-803, Hawaii Revised Statutes, is
2	amended by	y amending subsection (a) to read as follows:
3	"(a)	In addition to establishing standards for the
4	issuance	and renewal of licenses and any other powers and duties
5	authorize	d by law, the board's powers shall also include:
6	(1)	Setting and administering its own budget;
7	(2)	Adopting, amending, or repealing the rules of the
8		board in accordance with chapter 91;
9	(3)	Receiving grants or donations from private
10		foundations, and state and federal funds;
11	(4)	Submitting an annual report to the governor, the
12		legislature, and the board of education on the board's
13		operations and expenditures, and from the 2007-2008
14		school year, submitting a summary report every five
15		years of the board's accomplishment of objectives,
16		efforts to improve or maintain teacher quality, and

efforts to keep its operations responsive and

efficient;

1	"§302A-808 Penalty. Any person who engages in the
2	profession of teaching in a public school without first being
3	issued a license or hired on an emergency basis as defined in
4	this chapter shall be fined not more than \$500. Any person who
5	knowingly or intentionally violates this subpart by employing an
6	individual as a public school teacher who does not possess a
7	valid license or is not a department of education or charter
8	school emergency hire as defined in this chapter may be fined
9	not more than \$500. All fines shall be deposited into the
10	[Hawaii teacher standards board special fund.] general fund."
11	SECTION 3. Section 302A-806, Hawaii Revised Statutes, is
12	repealed.
13	["§302A-806 Hawaii teacher standards board special fund.
14	There is established within the state treasury a special fund to
15	be known as the Hawaii teacher standards board special fund,
16	into which shall be deposited all moneys received by the board
17	in the form of appropriations, fees, fines, grants, donations,
18	or revenues regardless of their source. The special fund shall
19	be administered by the department and used to pay the expenses
20	of the board, including but not limited to the payment of all

- 1 operational and personnel costs, and reimbursements to board
- 2 members for travel expenses incurred."
- 3 SECTION 4. On July 1, 2019, all unencumbered balances
- 4 remaining in the Hawaii teacher standards board special fund
- 5 repealed by this Act shall lapse to the credit of the general
- 6 fund.
- 7 SECTION 5. Statutory material to be repealed is bracketed
- 8 and stricken. New statutory material is underscored.
- 9 SECTION 6. This Act shall take effect on July 1, 2019.
