# A BILL FOR AN ACT

RELATING TO ONSITE-NON-POTABLE WATER REUSE SYSTEMS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1  | SECTION 1. The legislature finds that as an island state,        |

| 2  | Hawaii has limited access to natural fresh water and unlike in   |
| 3  | other states, it is not economically feasible to ship in         |
| 4  | additional supplies when needed. Competition for fresh water     |
| 5  | from increasing populations, development pressures, and the      |
| 6  | impact of climate change require that Hawaii develop strategies  |
| 7  | for increasing water conservation, recharge, and reuse in order  |
| 8  | to ensure fresh water supplies for current and future            |
| 9  | generations. The Hawaii fresh water initiative was developed as  |
| 10 | a statewide goal to increase water security by one hundred       |
| 11 | million gallons a day by 2030. This will require more than       |
| 12 | doubling the amount of wastewater currently reused in the        |
| 13 | islands to provide an additional thirty million gallons a day in |
| 14 | water availability. To reach this goal, both regional, large     |
| 15 | scale recycled water projects as well as smaller scale building  |

level projects will be needed.

| I  | The legislature further finds that the use of recycled           |

| 2  | water for non-potable applications has been proven safe and      |
| 3  | feasible under existing regulatory regimes in Hawaii and many    |
| 4  | other states, as well as in other industrialized countries of    |
| 5  | the world. The opportunity for non-potable reuse at the          |
| 6  | building level is high. According to the United States           |
| 7  | Environmental Protection Agency, up to ninety-five per cent of   |
| 8  | water demands are for non-potable uses in commercial buildings,  |
| 9  | with irrigation and cooling tower representing approximately     |
| 10 | fifty per cent of that demand. Onsite water reuse in high-rise   |
| 11 | and mid-rise developments in particular has proven feasible and  |
| 12 | safe in New York, California, Japan, Australia, and other        |
| 13 | locations. The use of recycled water generated onsite at high-   |
| 14 | rise and mid-rise developments can replace a large percentage of |
| 15 | the future potable water demand of such developments.            |
| 16 | In order to safely increase onsite water reuse at the            |
| 17 | development level, the legislature finds that guidance from the  |
| 18 | Water Environment and Reuse Foundation, US Water Alliance, and   |
| 19 | the Water Research Foundation's National Blue Ribbon Commission  |
| 20 | for Onsite Non-potable Water Systems (Commission) would be       |
| 21 | invaluable. This Commission, made up of representatives from     |

- 1 municipalities, water utilities, and public health agencies
- 2 including Hawaii's department of health advances best management
- 3 practices to support the use of onsite non-potable water reuse
- 4 systems within individual buildings or at the local scale
- 5 through a commitment to protect public health and the
- 6 environment. To support the adoption of onsite non-potable
- 7 water reuse systems, the Commission has developed tools and
- 8 resources based on world class research and best practices
- 9 underway in local communities.
- 10 To help reach the 2030 goal for water reuse, the department
- 11 of health organized a water reuse task force based on House
- 12 Concurrent Resolution 86, S.D. 1 (2018), with the purpose of
- 13 identifying policies to help scale water reuse in the Hawaiian
- 14 islands. Task force participants included representatives from
- 15 the department of health, board of land and natural resources,
- 16 commission on water resources management, board of agriculture,
- 17 Honolulu board of water supply, Hawaii freshwater initiative,
- 18 Hawaii Community Foundation, county representatives, and members
- 19 of the house of representatives and the senate.
- 20 The purpose of this Act is to require the department of
- 21 health to adopt rules for onsite non-potable water reuse systems

- by January 1, 2021. The rules shall be informed and guided by 1
- 2 the work of the water reuse task force and have the goal of
- 3 safely, effectively, and economically scaling water reuse
- 4 throughout Hawaii.
- SECTION 2. By January 1, 2021, the department of health 5
- 6 shall adopt a localized set of rules for onsite non-potable
- 7 water reuse systems with guidance from the Water Environment and
- 8 Reuse Foundation and the Water Research Foundation's "A
- 9 Guidebook for Developing and Implementing Regulations for Onsite
- 10 Non-Potable Water Systems," which focuses on public safety and
- 11 minimizing public risk and was created with the support of
- 12 public health regulators.
- SECTION 3. This Act shall take effect on July 1, 2019. **13**
