## A BILL FOR AN ACT

RELATING TO THE UNIFORM PARENTAGE ACT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 584, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§584- Court filings; minutes of proceedings; posting
- 5 requirement. The judiciary shall post on its website the titles
- 6 of all court filings and the minutes of court proceedings in
- 7 cases brought under this chapter; provided that the judiciary
- 8 shall redact information that has been made confidential by any
- 9 statute, rule of court, or court order; provided further that,
- 10 on request of a party and for good cause, the court may close a
- 11 proceeding and records to the public except that the titles of
- 12 all court filings for the case and the contents of a final order
- 13 shall be available for public inspection, with other papers and
- 14 records available for public inspection only with the consent of
- the parties or by court order."
- 16 SECTION 2. Section 571-84, Hawaii Revised Statutes, is
- 17 amended by amending subsection (a) to read as follows:

"(a) The court shall maintain records of all cases brought 2 before it. Except as provided in [section] sections  $571-84.6[_{T}]$ 3 and 584- , in proceedings under section 571-11 and in paternity 4 proceedings under chapter 584, the following records shall be 5 withheld from public inspection: the court docket, petitions, complaints, motions, and other papers filed in any case; 6 7 transcripts of testimony taken by the court; and findings, 8 judgments, orders, decrees, and other papers other than social 9 records filed in proceedings before the court. The records 10 other than social records shall be open to inspection: by the 11 parties and their attorneys, by an institution or agency to 12 which custody of a minor has been transferred, and by an 13 individual who has been appointed guardian; with consent of the 14 judge, by persons having a legitimate interest in the 15 proceedings from the standpoint of the welfare of the minor; 16 and, pursuant to order of the court or the rules of court, by 17 persons conducting pertinent research studies, and by persons, 18 institutions, and agencies having a legitimate interest in the 19 protection, welfare, treatment, or disposition of the minor." 20 SECTION 3. Section 584-20, Hawaii Revised Statutes, is 21 amended to read as follows:

- 1 "§584-20 Hearings and records; confidentiality. (a)
- 2 Notwithstanding any other law concerning public hearings and
- 3 records, any hearing or trial held under this chapter shall be
- 4 held in closed court without admittance of any person other than
- 5 those persons necessary to the action or proceeding. All papers
- 6 and records pertaining to the action or proceeding, whether part
- 7 of the permanent record of the court or of a file in the
- 8 department of health or elsewhere, shall be subject to
- 9 inspection only upon consent of the court and all interested
- 10 persons, or in exceptional cases only upon an order of the court
- 11 for good cause shown.
- (b) Upon paternity being established, the confidentiality
- 13 requirement shall not extend to the judgment and all
- 14 subsequently filed documents that are used in good faith for
- 15 support and medical expenses, insurance, or enforcement
- 16 purposes, except that the confidentiality requirement shall
- 17 continue to apply to any references to a non-adjudicated alleged
- 18 or presumed father.
- (c) Subsections (a) and (b) shall not apply to cases filed
- 20 on and after the effective date of this Act , Session Laws of
- 21 Hawaii 2019."

- 1 SECTION 4. This Act does not affect rights and duties that
- 2 matured, penalties that were incurred, and proceedings that were
- 3 begun before its effective date.
- 4 SECTION 5. Statutory material to be repealed is bracketed
- 5 and stricken. New statutory material is underscored.
- 6 SECTION 6. This Act shall take effect on January 1, 2021.
