ACT 242 S.B. NO. S.D. 1

A BILL FOR AN ACT

RELATING TO OCULARISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that existing law in
- 2 Hawaii relating to ocularists, those who design, fit, and
- 3 fabricate artificial eyes under the supervision of a licensed
- 4 ophthalmologist or optometrist, provides that a certified
- 5 ocularist may perform within the scope of the ocularist's
- 6 certification if the certified ocularist is "recognized" by the
- 7 American Society of Ocularists. The legislature further finds
- 8 that the American Society of Ocularists is not a certifying
- 9 board or organization. Therefore, the standard to allow an
- 10 ocularist to conduct business in Hawaii should be whether an
- 11 ocularist is certified by a nationally recognized ocularistry
- 12 certifying board.
- 13 SECTION 2. Section 458-14, Hawaii Revised Statutes, is
- 14 amended by amending subsection (b) to read as follows:
- 15 "(b) Nothing in this chapter shall be construed to
- 16 prohibit a certified ocularist [as recognized by the American
- 17 Society of Ocularists] who is certified by the American Board of
- 18 Ocularistry, the National Examining Board of Ocularists, or any



- 1 other nationally recognized ocularistry certifying board from
- 2 performing within the scope of such certification; provided that
- 3 the ocularist performs only those functions dealing with the
- 4 designing, fitting, and fabricating of artificial eyes, and not
- 5 contact lenses of refractive value, and is under the supervision
- 6 of a licensed ophthalmologist or optometrist. The ocularist
- 7 shall inform the [board] director in writing of the name of the
- 8 supervising ophthalmologist or optometrist."
- 9 SECTION 3. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 4. This Act shall take effect upon its approval.
