
A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE III, SECTION 4, OF THE HAWAII
STATE CONSTITUTION TO ESTABLISH LEGISLATIVE TERM LIMITS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to propose an
2 amendment to article III, section 4, of the Constitution of the
3 State of Hawaii to limit the terms of members of the legislature
4 to a maximum of six consecutive full terms in the house of
5 representatives or three consecutive full terms in the senate.

6 SECTION 2. Article III, section 4, of the Constitution of
7 the State of Hawaii is amended to read as follows:

8 **"ELECTION OF MEMBERS; TERM**

9 **Section 4.** Each member of the legislature shall be elected
10 at an election. If more than one candidate has been nominated
11 for election to a seat in the legislature, the member occupying
12 that seat shall be elected at a general election. If a
13 candidate nominated for a seat at a primary election is
14 unopposed for that seat at the general election, the candidate
15 shall be deemed elected at the primary election. The term of
16 office of a member of the house of representatives shall be two



1 years and the term of office of a member of the senate shall be
2 four years[-]; provided that for terms beginning on or after the
3 general election of 2024, no member of the legislature shall
4 serve for more than six consecutive full terms in the house of
5 representatives or three consecutive full terms in the senate.

6 The term of a member of the legislature shall begin on the day
7 of the general election at which elected or if elected at a
8 primary election, on the day of the general election immediately
9 following the primary election at which elected. For a member
10 of the house of representatives, the term shall end on the day
11 of the general election immediately following the day the
12 member's term commences. For a member of the senate, the term
13 shall end on the day of the second general election immediately
14 following the day the member's term commences."

15 SECTION 3. The question to be printed on the ballot shall
16 be as follows:

17 "Shall members of the legislature be limited to serving a
18 maximum of six consecutive full terms in the house of
19 representatives or three consecutive full terms in the
20 senate, for terms beginning on or after the general
21 election of 2024?"

4 SECTION 5. This amendment shall take effect upon
5 compliance with article XVII, section 3, of the Constitution of
6 the State of Hawaii.
