A BILL FOR AN ACT

RELATING TO THE STATE BUDGET.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I. PROGRAM APPROPRIATIONS
2	SECTION 1. There is appropriated from the agricultural
3	loan reserve fund the sum of \$79,998 or so much thereof as may
4	be necessary for fiscal year 2019-2020 and the same sum or so
5	much thereof as may be necessary for fiscal year 2020-2021 for
6	financial assistance for agriculture (AGR101) to establish one
7	full-time equivalent (1.0 FTE) permanent business loan officer
8	The sums appropriated shall be expended by the department
9	of agriculture for the purposes of this Act.
10	SECTION 2. There is appropriated out of the general
11	revenues of the State of Hawaii the sum of \$350,000 or so much
12	thereof as may be necessary for fiscal year 2019-2020 for
13	quality and price assurance (AGR151) for food safety grants
14	pursuant to section 141-12.5, Hawaii Revised Statutes.
15	The sums appropriated shall be expended by the department
16	of agriculture for the purposes of this Act.

- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$240,000 or so much
- 3 thereof as may be necessary for fiscal year 2019-2020 for
- 4 agricultural development and marketing (AGR171) for Hawaii
- 5 specific agricultural surveys.
- 6 The sums appropriated shall be expended by the department
- 7 of agriculture for the purposes of this Act.
- 8 SECTION 4. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$90,000 or so much
- 10 thereof as may be necessary for fiscal year 2019-2020 and the
- 11 same sum or so much thereof as may be necessary for fiscal year
- 12 2020-2021 for general administration for agriculture (AGR192) to
- 13 establish one full-time equivalent (1.0 FTE) permanent exempt
- 14 special assistant to the director of agriculture; provided that
- 15 the director of agriculture shall appoint the special assistant
- 16 without regard to chapter 76, Hawaii Revised Statutes.
- 17 The sums appropriated shall be expended by the department
- 18 of agriculture for the purposes of this Act.
- 19 SECTION 5. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$1,038,240 or so much
- 21 thereof as may be necessary for fiscal year 2019-2020 and the

- 1 sum of \$1,263,902 or so much thereof as may be necessary for
- 2 fiscal year 2020-2021 for enterprise technology services -
- 3 governance and innovation (AGS130) for cybersecurity capability
- 4 enhancements.
- 5 The sums appropriated shall be expended by the office of
- 6 enterprise technology services for the purposes of this Act.
- 7 SECTION 6. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$750,000 or so much
- 9 thereof as may be necessary for fiscal year 2019-2020 for
- 10 economic planning and research (BED130) for the 2020 census
- 11 outreach; provided that the department may receive matching
- 12 funds of \$250,000 from private contributions for the purpose for
- 13 which this sum is appropriated.
- 14 The sums appropriated shall be expended by the department
- 15 of business, economic development, and tourism for the purposes
- 16 of this Act.
- 17 SECTION 7. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- 19 thereof as may be necessary for fiscal year 2019-2020 for
- 20 general support for economic development (BED142) for the
- 21 festival of pacific arts to be held in Honolulu.

- 1 The sums appropriated shall be expended by the department
- 2 of business, economic development, and tourism for the purposes
- 3 of Act 104, Session Laws of Hawaii 2017.
- 4 SECTION 8. There is appropriated from the Hawaii community
- 5 development revolving fund the sum of \$180,294 or so much
- 6 thereof as may be necessary for fiscal year 2019-2020 and the
- 7 same sum or so much thereof as may be necessary for fiscal year
- 8 2020-2021 for Hawaii community development authority (BED150)
- 9 for operating expenses of the Hawaii community development
- 10 authority.
- 11 The sums appropriated shall be expended by the Hawaii
- 12 community development authority for the purposes of this Act.
- 13 SECTION 9. There is appropriated from the public utilities
- 14 commission special fund the sum of \$584,000 or so much thereof
- 15 as may be necessary for fiscal year 2019-2020 and the same sum
- 16 or so much thereof as may be necessary for fiscal year 2020-2021
- 17 for consumer advocate for communication, utilities, and
- 18 transportation services (CCA103) to establish five full-time
- 19 equivalent (5.0 FTE) permanent positions.
- 20 The sums appropriated shall be expended by the department
- 21 of commerce and consumer affairs for the purposes of this Act.

1 SECTION 10. There is appropriated from the compliance 2 resolution fund business registration sub account the sum of 3 \$83,368 or so much thereof as may be necessary for fiscal year 2019-2020 and the same sum or so much thereof as may be 4 necessary for fiscal year 2020-2021 for business registration 5 6 and securities regulation (CCA111) for personal services for the conversion of one office assistant III to a staff attorney. 7 8 The sums appropriated shall be expended by the department 9 of commerce and consumer affairs for the purposes of this Act. 10 SECTION 11. There is appropriated from the public 11 utilities commission special fund the sum of \$200,240 or so much 12 thereof as may be necessary for fiscal year 2019-2020 and the 13 sum of \$195,840 or so much thereof as may be necessary for 14 fiscal year 2020-2021 for public utilities commission (CCA901) 15 to establish two full-time equivalent (2.0 FTE) permanent 16 enforcement officer positions and other expenses. **17** The sums appropriated shall be expended by the department 18 of commerce and consumer affairs for the purposes of this Act. 19 SECTION 12. There is appropriated out of the general 20 revenues of the State of Hawaii the sum of \$52,956 or so much

thereof as may be necessary for fiscal year 2019-2020 and the

- 7 SECTION 13. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$100,000 or so much
- 9 thereof as may be necessary for fiscal year 2019-2020 and the
- 10 same sum or so much thereof as may be necessary for fiscal year
- 11 2020-2021 for the office of the governor (GOV100) to establish
- 12 one full-time equivalent (1.0 FTE) temporary state disaster
- 13 recovery coordinator.
- 14 The sums appropriated shall be expended by the office of
- 15 the governor for the purposes of this Act.
- 16 SECTION 14. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$150,000 or so much
- 18 thereof as may be necessary for fiscal year 2019-2020 for office
- 19 of the governor (GOV100) for protocol expenses related to events
- 20 at Washington Place.

- 1 The sums appropriated shall be expended by the office of
- 2 the governor for the purposes of this Act.
- 3 SECTION 15. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$20,000 or so much
- 5 thereof as may be necessary for fiscal year 2019-2020 for
- 6 general administration DHS (HMS904) to establish a joint
- 7 outreach center located in Kaneohe.
- 8 The sums appropriated shall be expended by the department
- 9 of human services for the purposes of this Act.
- 10 SECTION 16. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$750,000 or so much
- 12 thereof as may be necessary for fiscal year 2019-2020 for family
- 13 health services (HTH560) for family planning.
- 14 The sums appropriated shall be expended by the department
- 15 of health for the purposes of this Act.
- 16 SECTION 17. There is appropriated from moneys in the
- 17 treasury received from federal grants the sum of \$39,292 or so
- 18 much thereof as may be necessary for fiscal year 2019-2020 and
- 19 the same sum or so much thereof as may be necessary for fiscal
- 20 year 2020-2021 for environmental health administration (HTH849).

- 1 The sums appropriated shall be expended by the department
- 2 of health for the purposes of this Act.
- 3 SECTION 18. There is appropriated from moneys in the
- 4 treasury received from revolving funds the sum of \$21,553 or so
- 5 much thereof as may be necessary for fiscal year 2019-2020 and
- 6 the same sum or so much thereof as may be necessary for fiscal
- 7 year 2020-2021 for environmental health administration (HTH849).
- 8 The sums appropriated shall be expended by the department
- 9 of health for the purposes of this Act.
- 10 SECTION 19. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$500,000 or so much
- 12 thereof as may be necessary for fiscal year 2019-2020 and the
- 13 same sum or so much thereof as may be necessary for fiscal year
- 14 2020-2021 for water and land development (LNR141) for the Hawaii
- 15 association of conservation districts.
- 16 The sums appropriated shall be expended by the department
- 17 of land and natural resources for the purposes of this Act.
- 18 SECTION 20. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$480,000 or so much
- 20 thereof as may be necessary for fiscal year 2019-2020 and the
- 21 same sum or so much thereof as may be necessary for fiscal year

- 1 2020-2021 for parks administration and operation (LNR806) for
- 2 lifeguard services at Kua Bay on Hawaii island.
- 3 The sums appropriated shall be expended by the department
- 4 of land and natural resources for the purposes of this Act.
- 5 SECTION 21. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$53,000 or so much
- 7 thereof as may be necessary for fiscal year 2019-2020 and the
- 8 same sum or so much thereof as may be necessary for fiscal year
- 9 2020-2021 for LNR natural and physical environment (LNR906) to
- 10 establish one full-time equivalent (1.0 FTE) temporary cultural
- 11 resource project coordinator for the Kahoolawe island reserve
- 12 commission.
- 13 The sums appropriated shall be expended by the department
- 14 of land and natural resources for the purposes of this Act.
- 15 SECTION 22. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$100,000 or so much
- 17 thereof as may be necessary for fiscal year 2019-2020 for LNR -
- 18 natural and physical environment (LNR906) for operating expenses
- 19 of the Kahoolawe island reserve commission.
- The sums appropriated shall be expended by the department
- 21 of land and natural resources for the purposes of this Act.

- 19 SECTION 25. There is appropriated out of the general
- 20 revenues of the State of Hawaii the sum of \$1,897,827 or so much
- 21 thereof as may be necessary for fiscal year 2020-2021 for

- 1 women's community correctional center (PSD409) to establish
- 2 twenty three full-time equivalent (23.0 FTE) permanent positions
- 3 and operating expenses for the Ho'okipa cottage; provided that

- 6 of public safety for the purposes of this Act.
- 7 SECTION 26. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$2,690,450 or so much

- 10 same sum or so much thereof as may be necessary for fiscal year

- 19 2020-2021 for narcotics enforcement (PSD502) to fund one full-
- 20 time equivalent (1.0 FTE) permanent investigator V.

- 1 The sums appropriated shall be expended by the department
- 2 of public safety for the purposes of this Act.
- 3 SECTION 28. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$85,800 or so much
- 5 thereof as may be necessary for fiscal year 2020-2021 for
- 6 narcotics enforcement (PSD502) for personal services for two
- 7 full-time equivalent (2.0 FTE) permanent criminalist I
- 8 positions.
- 9 The sum appropriated shall be expended by the department of
- 10 public safety for the purposes of this Act.
- 11 SECTION 29. There is appropriated from the state highway
- 12 fund the sum of \$147,321 or so much thereof as may be necessary

- 19 thereof as may be necessary for fiscal year 2019-2020 and the
- 20 same sum or so much thereof as may be necessary for fiscal year
- 21 2020-2021 for in-community youth programs (HMS501) to fund one

- 1 existing full-time equivalent (1.0 FTE) permanent corrections
- 2 program specialist II; provided that, notwithstanding any
- 3 provision contained in the General Appropriations Act of 2019
- 4 that appropriates funds and establishes position ceilings, the
- 5 position authorized in this section shall be in addition to the
- 6 positions authorized for that program under the General
- 7 Appropriations Act of 2019; provided further that any incumbent
- 8 employee shall retain the employee's:
- 9 (1) Civil service status, whether permanent or temporary;
- **10** and
- 11 (2) Salary, seniority (except as may be prescribed by
- applicable collective bargaining agreement), retention
- points, prior service credit, any vacation and sick
- leave credits previously earned, and other rights,

- 5 thereof as may be necessary for fiscal year 2019-2020 for in-
- 6 community youth programs (HMS501) to fund existing juvenile
- 7 justice reform programs.
- 8 The sum appropriated shall be expended by the department of
- 9 human services for the purposes of this Act.
- 10 PART II. PROVISIONS
- 11 SECTION 32. Provided that of the general fund
- 12 appropriation in section 3 of Act 5, Session Laws of Hawaii
- 13 2019, for public works planning, design, and construction
- 14 (AGS221), the sum of \$250,000 or so much thereof as may be
- 15 necessary for fiscal year 2019-2020 shall be expended for the
- 16 implementation of a proof of concept study to update the Wahiawa
- 17 Civic Center Master Plan, which shall include a new courthouse,
- 18 facilities for current state tenants, facilities for other state
- 19 agencies, and the optimization of facility space and land uses
- 20 for the provision of services to the community.

- 1 SECTION 33. Provided that of the general funds
- 2 appropriated by section 3 of Act 5, Session Laws of Hawaii 2019,
- 3 for adult parole supervision and counseling (PSD612), the sum of
- 4 \$250,000 or so much thereof as may be necessary for fiscal year
- 5 2019-2020 shall be expended on a pre-entry and post-entry
- 6 program for inmates by a federally qualified health center that
- 7 operates an existing pre-entry and post-entry program for
- 8 inmates.
- 9 SECTION 34. If any portion of this Act or its application
- 10 to any person, entity, or circumstance is held to be invalid for
- 11 any reason, then the legislature declares that the remainder of
- 12 the Act and each and every other provision thereof shall not be
- 13 affected thereby. If any portion of a specific appropriation is
- 14 held to be invalid for any reason, the remaining portion shall
- 15 be expended to fulfill the objective of such appropriation to
- 16 the extent possible.
- 17 SECTION 35. If manifest clerical, typographical, or other
- 18 mechanical errors are found in this Act, the governor may
- 19 correct the errors.
- 20 SECTION 36. This Act shall take effect on July 1, 2019.
