

A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that improving our

2 schools begins by setting a goal and having a vision. The state

3 department of education strategic plan sets goals to increase

4 student engagement, student empowerment, and support for its

5 employees. Often a vision can stem from observations of best

6 practices adopted in other states. Examples of best practices

7 include operations that emphasize peer-to-peer learning and

8 teacher-personnel engagement.

9 The legislature finds that Massachusetts is making notable

advances in education, as evidenced by its internationally

11 competitive assessment results, educational practices, and

12 student learning outcomes. Massachusetts established a

13 collaborative planning and expanded learning time initiative

geared toward better supporting the growth of its teachers and

15 students. The Massachusetts public school system is similar to

16 the public school system in Hawaii.

1	The p	purpose of this Act is to establish and implement a
2	model pile	ot program within one department of education complex
3	area.	
4	SECT	ION 2. (a) Beginning with school year 2019-2020, the
5	department	t of education shall establish and implement a four-
6 1	year pilo	t program within one complex area.
7	(b)	The pilot program may provide public school teachers
8	with at lo	east forty-five minutes every school day for:
9	(1)	Individual teacher preparation time to allow teachers
10		to adequately prepare for instruction the following
11		day;
12	(2)	Collaborative teacher preparation time to allow
13		opportunities for like-grade teachers to facilitate
14		conversation amongst each other regarding effective
15		pedagogy in the classrooms to create high-quality
16		lesson plans; and
17	(3)	Teachers to, at the start of each school day or prior
18		to the conclusion of each school day, work with
19		students who are struggling with any lesson taught

earlier that day or the preceding day.

1	(6)	The department of education may structure public
2	school cla	assroom operations within the pilot program complex
3	area in th	ne following ways:
4	(1)	Classroom desks may be placed in clusters or pods to
5		facilitate and encourage peer-led group learning; and
6	(2)	Elementary teachers and teacher assistants may work in
7		pairs based on complementary strengths or backgrounds.
8		Elementary teachers and teacher assistants with
9		educational backgrounds in math or science may be
10		paired with an elementary teacher or teacher assistant
11		whose educational background is in reading or the
12		arts.
13	(d)	The public school principals and vice principals in
14	the pilot	program complex area may adopt the following
15	practices	: -
16	(1)	Each principal may rotate amongst the public
17		elementary, middle or intermediate, and high schools
18		in the designated complex area. The rotation may be

based upon where the highest need or demand for

administrative support is so that principals are

actively available to all teachers and students; and

1	(2)	Principals and vice principals may rotate time in each
2		public school classroom to observe educational
3		practices; provided that the intent of the
4		observations is to offer a tool to increase
5		professional growth and further develop effective
6		teaching, not monitor teacher performance.
7	(e)	The department of education may implement project-
8	based lear	ming into the curriculum of this pilot program.
9	(f)	The department of education shall submit an annual
10	report of	its findings to the legislature no later than twenty
11	days prior	to the convening of each regular session.
12	SECTI	ON 3. There is appropriated out of the general
13	revenues c	of the State of Hawaii the sum of \$250,000 or so much
14	thereof as	s may be necessary for fiscal year 2019-2020 and the
15	same sum c	or so much thereof as may be necessary for fiscal year
16	2020-2021	to establish and implement a model pilot program

within one department of education complex area.
