# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF THE ATTORNEY GENERAL OPERATING  
BUDGET.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

**1** PART I. GENERAL PROVISIONS

**2** SECTION 1. The purpose of this Act is to establish the  
**3** operating budget for the fiscal biennium beginning July 1, 2019,  
**4** and ending June 30, 2021, for state executive branch programs  
**5** under the purview of the house of representatives standing  
**6** committee on judiciary.

**7** SECTION 2. DEFINITIONS. Unless otherwise clear from the  
**8** context, as used in this Act:

**9** "Expending agency" means the executive department,  
**10** independent commission, bureau, office, board, or other  
**11** establishment of the state government (other than the  
**12** legislature, office of Hawaiian affairs, and judiciary), the  
**13** political subdivisions of the State, or any quasi-public  
**14** institution supported in whole or in part by state funds, which  
**15** is authorized to expend specified appropriations made by this  
**16** Act.



1 Abbreviations, where used to denote the expending agency or  
2 a house of representatives standing committee, shall mean the  
3 following:

4 ATG Department of the attorney general

5 JUD House of representatives standing committee on  
6 judiciary

7 "Means of financing" or "MOF" means the source from which  
8 funds are appropriated or authorized to be expended for the  
9 programs and projects specified in this Act. All appropriations  
10 are followed by letter symbols. The letter symbols, where used,  
11 shall have the following meanings:

12 A General funds

13 B Special funds

14 N Federal funds

15 P Other federal funds

16 T Trust funds

17 U Interdepartmental transfers

18 W Revolving funds

19 "Position ceiling" means the maximum number of permanent  
20 and temporary full-time equivalent positions authorized for a



1 particular program during a specified period or periods, as  
2 denoted by an asterisk for permanent full-time equivalent  
3 positions and a pound sign for temporary full-time equivalent  
4 positions.

5 "Program ID" means the unique identifier for the specific  
6 program and consists of the abbreviation for the organization  
7 responsible for carrying out the program followed by the  
8 organization number for the program.

9 **PART II. PROGRAM APPROPRIATIONS**

10 **SECTION 3. APPROPRIATIONS.** The following sums, or so much  
11 thereof as may be sufficient to accomplish the purposes and  
12 programs designated herein, are hereby appropriated or  
13 authorized, as the case may be, from the means of financing  
14 specified to the expending agencies designated for the fiscal  
15 biennium beginning July 1, 2019, and ending June 30, 2021. The  
16 total expenditures and the number of positions in each fiscal  
17 year of the biennium shall not exceed the sums and the position  
18 ceilings indicated for each fiscal year, except as provided  
19 elsewhere in this Act or as provided by general law.

1                   **PART III. MISCELLANEOUS AND EFFECTIVE DATE**

2           SECTION 4. If any portion of this Act or its application  
3 to any person, entity, or circumstance is held to be invalid for  
4 any reason, then the legislature declares that the remainder of  
5 the Act and each and every other provision thereof shall not be  
6 affected thereby. If any portion of a specific appropriation is  
7 held to be invalid for any reason, the remaining portion shall  
8 be expended to fulfill the objective of the appropriation to the  
9 extent possible.

10          SECTION 5. If manifest clerical, typographical, or other  
11 mechanical errors are found in this Act, the governor may  
12 correct the errors.

13          SECTION 6. This Act shall take effect on July 1, 2019.
