## A BILL FOR AN ACT

RELATING TO EMERGENCY MEDICAL SERVICES.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Chapter 321, Hawaii Revised Statutes, is  
2 amended by adding a new section to part XVIII to be  
3 appropriately designated and to read as follows:

4           "§321-       Emergency medical services; fees. (a) The  
5 department may establish reasonable fees to be collected from  
6 individuals who are:

7           (1) Transported by emergency ambulance services to any  
8 medical facility; or

9           (2) Provided emergency medical services by emergency  
10 medical services personnel, including evaluations and  
11 treatment, but are not subsequently transported to a  
12 medical facility.

13           (b) The department may adopt rules pursuant to chapter 91  
14 necessary for the purpose of this section and to set reasonable  
15 fees."

16           SECTION 2. Section 321-233, Hawaii Revised Statutes, is  
17 amended to read as follows:



1 "[+] §321-233 [+] Rules. (a) The director of health may  
2 adopt, amend, and repeal rules necessary to the implementation  
3 of this part, subject to chapter 91.

4 (b) Rules adopted pursuant to this section shall include  
5 provisions permitting and regulating the transportation of  
6 individuals to medical facilities including but not limited to  
7 hospital emergency departments, trauma centers, urgent care  
8 clinics, freestanding surgical centers, and other medical  
9 facilities licensed by the department."

10 SECTION 3. Statutory material to be repealed is bracketed  
11 and stricken. New statutory material is underscored.

12 SECTION 4. This Act shall take effect upon its approval.

**Report Title:**
