
A BILL FOR AN ACT

RELATING TO COMMERCE AND CONSUMER AFFAIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Beginning on July 1, 2020, and ending on June
2 30, 2029, the department of commerce and consumer affairs shall
3 suspend all fees relating to the licensing or registration of
4 persons under its jurisdiction, including all fees established
