A BILL FOR AN ACT

MAKING AN APPROPRIATION TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the operating bylaws
- 2 of the National Collegiate Athletic Association for division I
- 3 members allows educational institutions to provide meals to
- 4 student-athletes as a benefit incidental to participation in
- 5 intercollegiate athletics; provided that the institution does
- 6 not provide student-athletes with a meal and cash for the same
- 7 meal. The bylaws also authorize institutions to provide a
- 8 student-athlete financial aid, including a board allowance
- 9 consisting of three meals per day or the institution's maximum
- 10 meal plan that is available to all students, whichever is
- 11 greater. The legislature further finds that, notwithstanding
- 12 these bylaws, the university of Hawaii, a division I member of
- 13 the National Collegiate Athletic Association, only provides
- 14 student-athletes with one meal per day.
- 15 The purpose of this Act is to appropriate funds to the
- 16 university of Hawaii to provide all student-athletes enrolled at

- 1 the university with two additional meals per day and for the
- 2 university of Hawaii athletics program.
- 3 SECTION 2. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so much
- 5 thereof as may be necessary for fiscal year 2019-2020 and the
- 6 same sum or so much thereof as may be necessary for fiscal year
- 7 2020-2021 for the university of Hawaii to provide all student-
- 8 athletes enrolled at the university with two additional meals
- 9 per day.
- 10 The sums appropriated shall be expended by the university
- 11 of Hawaii for the purposes of this Act.
- 12 SECTION 3. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so much
- 14 thereof as may be necessary for fiscal year 2019-2020 and the
- 15 same sum or so much thereof as may be necessary for fiscal year
- 16 2020-2021 for the university of Hawaii athletics program.
- 17 The sums appropriated shall be expended by the university
- 18 of Hawaii for the purposes of this Act.
- 19 SECTION 4. This Act shall take effect on July 1, 2050.
