

### A BILL FOR AN ACT

RELATING TO SUSTAINABILITY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that not only is climate
- 2 change real, but it is the overriding challenge of the twenty-
- 3 first century and one of the priority issues of the house of
- 4 representatives. Climate change poses immediate and long-term
- 5 threats to the State's economy, sustainability, security, and
- 6 way of life.
- 7 The legislature recognized in Act 8, Special Session Laws
- 8 of Hawaii 2005, that many quality-of-life issues, including
- 9 water quality, air quality, land use, energy, and ocean
- 10 resources, are important to the people of Hawaii and should be
- 11 the focus for planning Hawaii's future and created the Hawaii
- 12 2050 sustainability task force and Hawaii 2050 sustainability
- 13 plan to coordinate the actions needed to sustain a growing and
- 14 vibrant economy, while maintaining a high quality of life for
- 15 all residents and visitors.
- 16 The legislature recognized in Act 181, Session Laws of
- 17 Hawaii 2011, that the creation of the Hawaii 2050 sustainability



- 1 plan comes as the State faces a growing number of pressing
- 2 issues, including the steady deterioration of public
- 3 infrastructure, the lack of affordable housing, a continued
- 4 reliance on a service-based economy, the vulnerability of Hawaii
- 5 in a volatile global energy market, possible interruptions in
- 6 travel and to critical food supplies, threats to fragile island
- 7 ecosystems, ever-increasing numbers of residents, and an
- 8 increasing number of visitors over the long-term. These issues
- 9 all raise questions about the long-term limits of growth in the
- 10 State and highlight the need to begin planning and acting to
- 11 assure Hawaii's sustainable future.
- 12 A ten-year measurement update of the Hawaii 2050
- 13 sustainability plan (2008-2017) was published in March 2018 by
- 14 the office of the auditor with the assistance of the office of
- 15 planning, which evaluated the metrics and indicators established
- 16 in the Hawaii 2050 sustainability plan. The measurement update
- 17 identified the need for funding to perform a formal ten-year
- 18 update of the Hawaii 2050 sustainability plan.
- 19 The purpose of this Act is to establish a stronger policy
- 20 framework for Hawaii sustainability efforts by incorporating

- 1 sustainability coordination and planning into the duties and
- 2 responsibilities of the office of planning.
- 3 SECTION 2. Chapter 226, Hawaii Revised Statutes, is
- 4 amended by adding a new section to part II to be appropriately
- 5 designated and to read as follows:
- 6 "\$226- Hawaii 2050 sustainability plan. (a) The
- 7 Hawaii 2050 sustainability plan shall serve as the State's
- 8 climate and sustainability action plan to determine future
- 9 actions guiding the coordination and implementation of Hawaii's
- 10 sustainability and climate adaptation goals, principles, and
- 11 policies, and to define and implement state goals, objectives,
- 12 policies, and priority guidelines using sections 226-3 to 226-27
- 13 and 226-103 to 226-109, and chapter 225P, as guiding principles.
- 14 (b) The office of planning shall update the sustainability
- 15 plan to determine future actions guiding the coordination and
- 16 implementation of Hawaii's sustainability and climate adaptation
- 17 goals, principles, and policies, and to define and implement
- 18 state goals, objectives, policies, and priority guidelines using
- 19 sections 226-3 to 226-27 and 226-103 to 226-109, and chapter
- 20 225P, as guiding principles.

- 1 (c) The office of planning shall submit the sustainability
- 2 plan updated pursuant to subsection (b) to the legislature no
- 3 later than twenty days prior to the convening of the regular
- 4 session of 2021 and every tenth regular session thereafter."
- 5 SECTION 3. Act 8, Session Laws of Hawaii 2005, as amended
- 6 by Act 210, Session Laws of Hawaii 2006, is amended by amending
- 7 section 2 to read as follows:
- 8 "SECTION 2. Act 8, Special Session Laws of Hawaii 2005, is
- 9 amended as follows:
- 1. By amending section 4 to read:
- 11 "SECTION 4. Hawaii 2050 sustainability plan. (a) After
- 12 receipt of the task force's report, the office of the auditor
- 13 shall prepare the Hawaii 2050 sustainability plan. The plan
- 14 shall be prepared to define and implement state goals,
- 15 objectives, policies, and priority guidelines using sections
- 16 226-3 to 226-27, Hawaii Revised Statutes, as guiding principles.
- 17 The auditor shall seek input from all state departments. The
- 18 auditor shall also solicit public views and concerns in
- 19 preparation of the plan and shall incorporate all or a portion
- 20 of the recommendations reported by the Hawaii 2050 task force.

- 1 The plan shall serve as a guideline for funding and
- 2 implementation by state and county agencies. The office of
- 3 planning shall assist the auditor in reviewing the plan.
- 4 (b) The auditor shall submit the sustainability plan to
- 5 the legislature no later than twenty days before the convening
- 6 of the regular session of 2008.
- 7 (e) The auditor, with the assistance of the office of
- 8 planning, shall update the plan every ten years and report to
- 9 the legislature.] "
- 10 2. By amending section 7 to read:
- 11 "SECTION 7. The Hawaii 2050 task force shall cease to
- 12 operate after June 30, 2008.""
- SECTION 4. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$500,000 or so much
- 15 thereof as may be necessary for fiscal year 2019-2020 and the
- 16 same sum or so much thereof as may be necessary for fiscal year
- 17 2020-2021 for updating the Hawaii 2050 sustainability plan.
- 18 The sums appropriated shall be expended by the office of
- 19 planning for the purposes of this Act.
- 20 SECTION 5. Statutory material to be repealed is bracketed
- 21 and stricken. New statutory material is underscored.

1 SECTION 6. This Act shall take effect on July 1, 2019.

### Report Title:

Hawaii 2050 Sustainability Plan; Update; Office of Planning; Appropriation
