A BILL FOR AN ACT

RELATING TO HAWAII STATE AND CONTRACTED CORRECTIONAL FACILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 353C, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§353C- Correctional facility and community correctional
5	center deaths; reporting. (a) Within forty-eight hours, the
6	director shall report to the governor, and the governor shall
7	report to the legislature, the death of any:
8	(1) Correctional facility or community correctional center
9	employee who dies on the grounds of a correctional
10	facility or community correctional center where Hawaii
11	inmates reside or who sustains an injury on the
12	grounds of a correctional facility or community
13	correctional center where Hawaii inmates reside that
14	causes the death of the employee; and
15	(2) Hawaii inmate who is incarcerated in a state or
16	contracted correctional facility.

1	(b)	The report in subsection (a) shall include the
2	following	information:
3	(1)	The name of the decedent;
4	(2)	The gender and age of the decedent;
5	(3)	Whether the decedent was an inmate or an employee;
6	(4)	The location of the death or injury leading to the
7		death;
8	(5)	The date and time of the death;
9	(6)	The cause of death;
10	(7)	Any indication of sexual assault leading to the death;
11		and
12	(8)	A report of the clinical mortality review conducted in
13		response to the death, including correctional actions
14		to be taken;
15	provided	that when the official cause of death has been
16	determine	d, the director shall immediately report the official
17	cause of	death to the governor, and the governor shall
18	immediate	ly report the official cause of death to the
19	legislatu	re.
20	<u>(c)</u>	The director shall have the discretion to withhold
21	disclosur	e of the decedent's name or any information protected

- 2 the death to the next of kin."
- 3 SECTION 2. New statutory material is underscored.
- 4 SECTION 3. This Act shall take effect upon its approval.

Correctional Facilities Deaths; Reporting Requirements

Description:

Requires the Director of Public Safety, in the event of the death of an inmate who is in a state or contracted correctional facility, or death of a correctional facility or community correctional center employee, to provide a report to the Governor and Legislature with certain information regarding the death. Authorizes Director to withhold disclosure of decedent's name or other protected information pending notification of next of kin. (HB336 HD1)
