# A BILL FOR AN ACT

RELATING TO MEDICAL CANNABIS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that as licensed medical			
2	cannabis dispensaries have only been established since 2015,			
3	they are still a new and emerging industry and most production			
4	centers and facilities have only been operating for less than			
5	two years. The legislature further finds that there may be			
6	situations where the leadership within a licensed dispensary ha			
7	changed; however, existing law does not provide a process for			
8	the sale or transfer of any significant interest in a licensed			
9	dispensary.			
10	Accordingly, the purpose of this Act is to:			
11	(1) Provide a process for the voluntary or involuntary			
12	sale or transfer of a dispensary license; and			
13	(2) Repeal certain restrictions on medical cannabis			
14	dispensary operations and siting.			
15	SECTION 2. Chapter 329D, Hawaii Revised Statutes, is			
16	amended by adding a new section to be appropriately designated			
17	and to read as follows:			

1	"§329D- Sale or transfer of dispensary license. (a) In			
2	the event of death, legal incapacity, or permanent disability of			
3	an individual dispensary licensee, the relevant entity licensee			
4	shall notify the department within thirty days of the individua			
5	licensee's inability to continue in the individual's capacity as			
6	a licensee, and shall provide to the department within thirty			
7	days of the notice a plan for the sale or transfer of the			
8	individual license to another individual who meets all the			
9	requirements under this chapter and has been a resident of the			
10	State for not less than five years preceding the proposed date			
11	of transfer.			
12	(b) In the event of a voluntary resignation by an			
13	individual licensee, termination of an individual licensee's			
14	employment with an entity licensee with or without cause, or any			
15	other permanent separation of the relationship between an			
16	individual licensee and an entity licensee, the relevant entity			
17	licensee shall submit a plan to the department for approval at			
18	least thirty days prior to any sale or transfer of the			
19	individual license to another individual who shall meet all the			
20	requirements under this chapter and shall have been a resident

- 3 (c) The department may deny a request for transfer of
- 4 ownership if it deems the transferee has failed to meet all the
- 5 requirements of section 329D-3 for ownership."
- 6 SECTION 3. Section 329D-6, Hawaii Revised Statutes, is
- 7 amended as follows:
- 8 1. By amending subsection (e) to read:
- 9 "(e) Retail dispensing locations shall not be open for
- 10 retail sales before 8:00 a.m. or after 8:00 p.m., Hawaii-
- 11 Aleutian Standard Time, Monday through Sunday. [Retail
- 12 dispensing locations shall be closed on official state and
- 13 federal holidays.]"
- 14 2. By amending subsection (m) to read:
- 15 "(m) A dispensary shall not transport cannabis or
- 16 manufactured cannabis products to another county or another
- 17 island; provided that this subsection shall not apply to the
- 18 transportation of cannabis or any manufactured cannabis product
- 19 solely for the purposes of laboratory testing pursuant to
- 20 section 329D-8, and subject to subsection (j)[, if no certified
- 21 laboratory is located in the county or on the island where the

1	dispensary is located]; provided further that a dispensary shall		
2	only transport samples of cannabis and manufactured cannabis		
3	products for laboratory testing for purposes of this subsection		
4	in an amount and manner prescribed by the department, in rules		
5	adopted pursuant to this chapter, and with the understanding		
6	that state	e law and its protections do not apply outside of the	
7	jurisdict	ional limits of the State."	
8	SECT	ION 4. Section 329D-22, Hawaii Revised Statutes, is	
9	amended by	y amending subsection (a) to read as follows:	
10	"(a)	Medical cannabis production centers and dispensaries	
11	shall com	ply with all county zoning ordinances, rules, or	
12	regulations; provided that:		
13	(1)	A medical cannabis production center shall be	
14		permitted in any area in which agricultural production	
15		is permitted except as provided within this chapter;	
16		and	
17	(2)	No medical cannabis production center or dispensary	
18		shall be permitted within seven hundred fifty feet of	
19		the real property comprising a playground [, public	

housing project or complex, or school."
