## A BILL FOR AN ACT

RELATING TO COASTAL PLANNING.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds that sea level rise is  
2 the preeminent challenge and a pivotal issue for the State. The  
3 legislature in 2017 created the Hawaii climate change mitigation  
4 and adaptation commission through Act 32, Session Laws of Hawaii  
5 2017, and tasked the commission to focus on sea level rise and  
6 develop a report identifying vulnerabilities and recommending  
7 adaptations. The commission submitted the Hawaii Sea Level Rise  
8 Vulnerability and Adaptation Report in December 2017. The  
9 report found that global atmosphere and ocean warming is leading  
10 to sea level rise and studies of sea level rise predict between  
11 3.2 feet and six feet of sea level rise by 2100 under the high-  
12 end Intergovernmental Panel on Climate Change scenario. Under  
13 these conditions, Hawaii will face increased hurricane risk and  
14 coastal flooding and erosion hazards from high waves and storms.  
15           The legislature further finds that the commission's report  
16 recommended the following adaptation strategies:

1 (1) Ensuring that development does not take place in areas  
2 subject to coastal hazards associated with sea level  
3 rise; and

4 (2) Requiring that new development is built to be more  
5 resilient to sea level rise.

6 Planning for sea level rise is necessary to protect coastal  
7 structures, infrastructure, and environments.

8 The purpose of this Act is to require the incorporation of  
9 sea level rise projections in all new state plans and updates to  
10 existing state plans generated under the Hawaii State Planning  
11 Act pursuant to chapter 226, Hawaii Revised Statutes.

12 SECTION 2. Chapter 226, Hawaii Revised Statutes, is  
13 amended by adding a new section to be appropriately designated  
14 and to read as follows:

15 "§226- Sea level rise; plans. The State shall  
16 incorporate evaluations, predictions, and recommendations  
17 pertaining to sea level rise projections in the preparation of  
18 new plans and updates to existing plans. All new plans and  
19 updates shall incorporate findings of the Hawaii Sea Level Rise  
20 Vulnerability and Adaptation Report prepared by the Hawaii  
21 climate change mitigation and adaptation commission."
