
A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated from the sources of
3 funding indicated below to collective bargaining statewide (BUF
4 102) the following sums, or so much thereof as may be necessary,
5 to fund for fiscal biennium 2019-2021 all collective bargaining
6 cost items in the agreement negotiated with the exclusive
7 representative of collective bargaining unit (7):

13 SECTION 2. Funds appropriated by this part shall be

3 funding indicated below to collective bargaining statewide (BUF
4 102) the following sums, or so much thereof as may be necessary,
5 to fund for fiscal biennium 2019-2021, the salary increases and
6 other cost adjustments authorized by chapter 89C, Hawaii Revised
7 Statutes, for state officers and employees who are excluded from
8 collective bargaining and belong to the same compensation plans
9 as those officers and employees within bargaining unit (7):

20 SECTION 5. Salary increases and cost adjustments provided
21 in this Act for any officer or employee whose compensation is



1 paid, in whole or in part, from federal, special, or other funds
2 shall be paid wholly or proportionately, as the case may be,
3 from the respective funds.

4 SECTION 6. Funds appropriated or authorized by this Act
5 that are not expended or encumbered by June 30, 2020, and June
6 30, 2021, of the respective fiscal years, shall lapse as of
7 those dates.

8 SECTION 7. This Act shall take effect on January 1, 2050.
