BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 14. Funds appropriated or authorized by this Act
2 that are not expended or encumbered by June 30, 2020, and June
3 30, 2021, of the respective fiscal years, shall lapse as of
4 those dates.

5 SECTION 15. This Act shall take effect on January 1, 2050.
