A BILL FOR AN ACT

RELATING TO EMERGENCY MANAGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 127A-3, Hawaii Revised Statutes, is
- 2 amended by amending subsections (c), (d), and (e) to read as
- 3 follows:
- 4 "(c) The [director] administrator may, from funds allotted
- 5 therefor, employ technical, clerical, administrative, and other
- 6 personnel and make such expenditures as may be necessary.
- 7 (d) The [director] administrator shall coordinate the
- 8 activities of the agency with all county emergency management
- 9 agencies, other state agencies, other states, or federal
- 10 agencies involved in emergency management activities, and all
- 11 organizations for emergency management within the State, whether
- 12 public or private, and shall maintain liaison and cooperate with
- 13 all county emergency management agencies, other state agencies,
- 14 other states, or federal agencies involved in emergency
- 15 management activities as provided in this chapter.
- 16 (e) The agency shall perform emergency management
- 17 functions within the territorial limits of the State[; support



1	county emergency management agencies as requested; coordinate
2	all resource support to the counties; ensure that emergency
3	management plans across the State are coordinated with each
4	other and other state, federal, and local organizations; oversee
5	and coordinate the statewide outdoor siren warning system;
6	monitor and issue alerts and warnings; and coordinate emergency
7	and disaster response and recovery activities]. In performing
8	its duties, the agency shall:
9	(1) Prepare a state comprehensive emergency management
10	plan, which shall be integrated into and coordinated
11	with the emergency management plans of the federal
12	government. The plan shall be integrated by a
13	continuous, integrated comprehensive emergency
14	management program. The plan shall contain provisions
15	to ensure that the state is prepared for emergencies
16	and minor, major, and catastrophic disasters. The
17	agency shall work closely with agencies and
18	organizations with emergency management
19	responsibilities in preparing and maintaining the
20	plan;

I	(2)	Assign lead and support responsibilities to state
2		agencies and personnel for emergency functions and
3		other support activities;
4	(3)	Adopt standards and requirements for county emergency
5		management plans. The standards and requirements
6		shall ensure that county plans are coordinated and
7		consistent with the state comprehensive emergency
8		management plan;
9	(4)	Make recommendations to the legislature, building code
10		organizations, and counties for zoning, building, and
11		other land use controls; and other preparedness,
12		prevention, and mitigation measures designed to
13		eliminate emergencies or reduce their impact;
14	(5)	Anticipate trends and promote innovations that will
15		enhance the emergency management system;
16	(6)	Institute statewide public awareness programs. This
17		shall include intensive public educational campaigns
18		on emergency preparedness issues, including but not
19		limited to the personal responsibility of individual
20		citizens to be self-sufficient for up to fourteen days
21		following a natural or human-caused disaster;

16		local government personnel on federal and state post-

19	(9)	Adopt standards and requirements for state agency
20		emergency operating procedures and review periodically
21		emergency operating procedures of state agencies and

1		recommend revisions as needed to ensure consistency		
2		with the state comprehensive emergency management plan		
3		and program; and		
4	(10)	Coordinate, in advance whenever possible, such		
5		executive orders, proclamations, and rules for		
6		issuance by the Governor as are necessary or		
7		appropriate for coping with emergencies and		
8		disasters."		
9	SECT	ION 2. Section 127A-5, Hawaii Revised Statutes, is		
10	amended by amending subsection (i) to read as follows:			
11	"(i) Each county, under the mayor's direction, shall			
12	coordinate, develop, and implement [an] a comprehensive			
13	emergency [operation] management plan for the county[-] and			
14	submit an	submit annual reports to the administrator on the status and		
15	updates of the plan."			
16	SECT	ION 3. Section 127A-6, Hawaii Revised Statutes, is		
17	amended t	o read as follows:		
18	"§12	7A-6 Emergency management reserve corps. (a) The		
19	[director	administrator may establish an emergency management		
20	recerve o	sorns comprising trained specialists to support state		

- 1 and county emergency [or], disaster, or day to day requirements.
- 2 The emergency management reserve corps may include:
- 3 (1) Any employee of the State or county;
- 4 (2) Any employee hired specifically for staffing during
- 5 emergency, disaster, or day to day periods and
- 6 exercises who shall be hired and compensated without
- 7 regard to chapters 76, 78, and 88; and
- **8** (3) Any volunteer,
- 9 who shall be detailed in accordance with this chapter.
- 10 Emergency management reserve corps positions shall be authorized
- 11 and managed by the agency and do not need the approval of the
- 12 governor.
- 13 (b) The emergency management reserve corps shall support
- 14 state emergency or disaster requirements and, if requested by a
- 15 county emergency management agency, supplement the county
- 16 emergency management agency staff. The emergency management
- 17 reserve corps may be mobilized during, or in advance of,
- 18 emergencies or disasters, or for emergency management [exercises
- 19 and training events.] day to day activities. Emergency
- 20 management reserve corps members shall attend a minimum of [four
- 21 days] forty hours of paid [training] activities per year."

1	SECT	ION 4. Section 127A-16, Hawaii Revised Statutes, is
2	amended to	read as follows:
3	" §12"	7A-16, Major disaster fund. (a) The [director]
4	administra	ator shall submit requests to the legislature to
5	appropria	te from the general revenues of the State sufficient
6	moneys as	may be necessary for expenditure by or under the
7	direction	of the governor for immediate relief in response to an
8	emergency	or disaster in any part of the State; provided that:
9	(1)	The governor has issued a proclamation of a state of
10		emergency;
11	(2)	The governor may not expend in excess of [\$5,000,000]
12		\$ for immediate relief as a result of any
13		single emergency or disaster; and
14	(3)	In addition to the funds in paragraph (2), an
15		additional \$5,000,000 may be made available solely for
16		the purpose of matching federal disaster relief funds
17		when these funds become available to the State
18		following a presidential disaster declaration.
19	In expend	ing the moneys, the governor may allot any portion
20	thereof t	o any agency, office, or employee of the State or a
21	county fo	r the most efficient relief for the population.

- 1 Notwithstanding this subsection, the only exception to
- 2 paragraphs (1), (2), and (3) is that the [director]
- 3 administrator may use up to [\$100,000] \$ per year to
- 4 support emergency management reserve corps [training].
- 5 (b) No later than [one month] sixty days after any
- 6 allotment by the governor or the expenditure of any fund moneys,
- 7 the [director] administrator shall report to the legislature on
- 8 the purpose of the allotment or expenditure.
- 9 (c) Except as provided in subsection (d), federal
- 10 reimbursement moneys for disaster relief shall be deemed to be
- 11 trust moneys and may be deposited into a trust account with and
- 12 under the control of the [department of defense.] Hawaii
- 13 emergency management agency. These moneys and any interest
- 14 earned thereon shall be used for the purpose identified in
- 15 subsection (a) and shall not lapse to the general fund.
- 16 (d) In cases in which the department of education expends
- 17 the funds appropriated to the department for purposes deemed to
- 18 be reimbursable by federal reimbursement moneys for disaster
- 19 relief, the federal reimbursement moneys shall not lapse to the
- 20 general fund and shall be credited directly to the department of
- 21 education without regard to whether the original appropriation



- 1 has lapsed. Such funds shall carry over in accordance with
- 2 section 37-41.5(c).
- 3 (e) Any unexpended funding under \$2,500,000 shall carry
- 4 over to the next fiscal year to support future emergencies and
- 5 disasters."
- 6 SECTION 5. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 6. This Act shall take effect on July 1, 2050.
