
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES TO
ESTABLISH A TASK FORCE TO CONDUCT A STUDY CONCERNING THE
CURRENT AND FUTURE NEEDS OF THE STATE ARCHIVES.

1 WHEREAS, the original State Archives Building, known as the
2 Kana'ina Building, was built in 1905 on the 'Iolani Palace
3 grounds, within the Hawai'i Capital Historic District, to house
4 the Public Archives of Hawai'i; and
5

6 WHEREAS, after many years of collecting and acquiring into
7 the Public Archives the most important records and artifacts of
8 the governments of Hawai'i from the Hawaiian Kingdom through
9 Statehood, the State Archives eventually outgrew the Kana'ina
10 Building; and
11

12 WHEREAS, in 1952, a new building adjacent to the Kana'ina
13 Building was constructed as the new home of the State Archives
14 and named after Kekāuluohi; and
15

16 WHEREAS, there exists a need to promote citizen engagement
17 in the documentary heritage of the government, provide greater
18 education on the history of Hawai'i's governments and its people,
19 and assist the people of Hawai'i in connecting with their
20 personal history as well as the history of Hawai'i; and
21

22 WHEREAS, there exists a need to have a dedicated display
23 space to highlight the many historic records and artifacts
24 preserved in the Public Archives that document the vibrant and
25 diverse history of Hawai'i, its public institutions, and its
26 people; and
27

28 WHEREAS, the Hawai'i Capital Historic District has been the
29 center of Hawai'i's government for over a century, now consists
30 of twenty buildings and structures, and was added to the
31 National Register of Historic Places on December 1, 1978; and

2 WHEREAS, the buildings and structures within the Hawai'i
3 Capital Historic District have distinct architectural styles,
4 ranging from the nineteenth century adaptations of New England
5 homes to the Italianate Renaissance Revival and Neoclassic
6 edifices of the Hawaiian Monarchy; and
7

8 WHEREAS, the current State Archives Building does not fit
9 architecturally with the other buildings of the Hawai'i Capital
10 Historic District; and
11

12 WHEREAS, the current State Archives Building not only
13 appears outdated, but is also outdated in function with
14 electrical and elevator problems requiring expensive repair
15 along with a lack of stable backup power, which puts the secure
16 storage of the records at risk; and
17

18 WHEREAS, the historical records of Hawai'i held at the State
19 Public Library, which is near the current State Archives
20 Building, should be stored in the same location and with the
21 same archival standards as the historical records held at the
22 State Archives; and
23

24 WHEREAS, aging, underrepresented, and marginalized segments
25 of the community seek to donate important historical documents
26 and artifacts to the State Archives, but a lack of storage space
27 in the current State Archives Building requires the State
28 Archivist to be very selective in accepting donations; now,
29 therefore,
30

31 BE IT RESOLVED by the House of Representatives of the
32 Thirtieth Legislature of the State of Hawaii, Regular Session of
33 2019, the Senate concurring, that the Department of Accounting
34 and General Services is requested to establish a task force to
35 conduct a study concerning the current and future needs of the
36 State Archives; and
37

38 BE IT FURTHER RESOLVED that the task force members be
39 selected as follows:

- 1 (1) Three members to be selected by the President of the
2 Senate; provided that at least one member is a member
3 of the Senate;
4
- 5 (2) Three members to be selected by the Speaker of the
6 House of Representatives; provided that at least one
7 member is a member of the House of Representatives;
8
- 9 (3) Three members to be selected by the Governor; and
10
- 11 (4) Four members to be selected by the Comptroller;
12 provided that at least two members be Archives
13 Division employees; and
14

15 BE IT FURTHER RESOLVED that the task force is requested to
16 select a chairperson from among its members; and
17

18 BE IT FURTHER RESOLVED that a vacancy on the task force
19 shall be filled by the same selection authority that appointed
20 the vacating member; and
21

22 BE IT FURTHER RESOLVED that seven members of the task force
23 shall constitute a quorum; provided that an affirmative vote of
24 five members shall be necessary for decision-making; and
25

26 BE IT FURTHER RESOLVED that the task force meeting schedule
27 shall be determined by the members; and
28

29 BE IT FURTHER RESOLVED that the task force shall be exempt
30 from chapter 92, Hawai'i Revised Statutes; and
31

32 BE IT FURTHER RESOLVED that members of the task force shall
33 not be considered state employees for the purposes of chapter
34 84, Hawai'i Revised Statutes, due solely to their service on the
35 task force; and
36

37 BE IT FURTHER RESOLVED that the task force is requested to
38 include in its study an analysis of the:
39

- 40 (1) Requirements of the State Archives to continue to
41 acquire the documentary and artifactual history of
42 Hawai'i and its people for the next fifty years;

- 2 (2) Expected suitability of the current Archives
- 3 facilities over the next fifty years;
- 4
- 5 (3) Space requirements to create a museum quality display
- 6 space for the Public Archives to educate the public
- 7 and visitors on the documentary and artifactual
- 8 history of Hawai'i, its public institutions, and its
- 9 people through exhibitions, educational seminars, and
- 10 interpretive displays;
- 11
- 12 (4) Suitability of renovating Kekāuluohi to conform to the
- 13 architectural style of the Hawai'i Capital Historic
- 14 District while updating its infrastructure to conform
- 15 to archival standards and meet the Archives' needs for
- 16 the next fifty years; using existing State facilities
- 17 to house or extend the operations of the State
- 18 Archives, or both; or constructing a new, suitable
- 19 facility to house the Public Archives and State
- 20 Archives' operations, or both;
- 21
- 22 (5) Capability of current and projected new facilities to
- 23 digitize the records of the Public Archives and
- 24 provide the necessary infrastructure to support the
- 25 Digital Archives;
- 26
- 27 (6) Feasibility of combining the historical documents or
- 28 archival records currently located at the State
- 29 Library into the records of the State Archives; and
- 30
- 31 (7) Utility of a Hawai'i Capital Historic District Visitor
- 32 Center in conjunction with any display space for the
- 33 Archives' holdings; and
- 34

35 BE IT FURTHER RESOLVED that the task force is requested to
36 submit a report of its findings and recommendations, including
37 any proposed legislation, to the Legislature no later than
38 twenty days prior to the convening of the Regular Session of
39 2020; and

41 BE IT FURTHER RESOLVED that certified copies of this
42 Concurrent Resolution be transmitted to the Governor,
