## HOUSE CONCURRENT RESOLUTION

URGING THE SMITHSONIAN INSTITUTION TO IMMEDIATELY RENAME THE  
ARTHUR M. SACKLER GALLERY.

1           WHEREAS, opioids are a class of drugs that includes the  
2 prescription pain relievers oxycodone, hydrocodone, codeine, and  
3 morphine; and  
4

5           WHEREAS, opioids are highly addictive, even when used as  
6 prescribed by a physician; and  
7

8           WHEREAS, in 2011, the Centers for Disease Control and  
9 Prevention declared opioid abuse a national epidemic; and  
10

11           WHEREAS, opioid overdoses claim more lives every year than  
12 motor vehicle accidents or gun violence; and  
13

14           WHEREAS, the prescription painkiller OxyContin, a brand  
15 name for oxycodone, is at the heart of this epidemic; and  
16

17           WHEREAS, OxyContin was developed by Purdue Pharma, owned  
18 and operated by the Sackler family; and  
19

20           WHEREAS, the Sackler family launched OxyContin with a  
21 multi-faceted marketing campaign that misinformed physicians  
22 about the risks of opioids; and  
23

24           WHEREAS, this campaign was led by doctors who were paid by  
25 Purdue Pharma and the Sackler family to falsely convince  
26 physicians of OxyCotin's safety and non-addictive properties;  
27 and

29           WHEREAS, Psychiatrist Allen Frances was quoted in the *New*  
30 *Yorker* as saying, "Most of the questionable practices that

1 propelled the pharmaceutical industry into the scourge it is  
2 today can be attributed to Arthur Sackler"; and  
3

4 WHEREAS, the Arthur M. Sackler Gallery is one of the  
5 Smithsonian Institution's two prestigious museums of Asian art;  
6 now, therefore,  
7

8 BE IT RESOLVED by the House of Representatives of the  
9 Thirtieth Legislature of the State of Hawaii, Regular Session of  
10 2019, the Senate concurring, that the Smithsonian Institution is  
11 urged to immediately rename the Arthur M. Sackler Gallery, in  
12 light of the family's significant contributions to today's  
13 opioid crisis; and

15 BE IT FURTHER RESOLVED that certified copies of this  
16 Concurrent Resolution be transmitted to the Secretary of the  
17 Smithsonian Institution, the Smithsonian Institution's Inspector  
18 General, the Smithsonian Institution's Chief Operating Officer,  
19 the Smithsonian Institution's Assistant Secretary for  
20 Communications and External Affairs, and the Smithsonian  
21 Institution's General Counsel.
