## HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF HUMAN SERVICES TO EXAMINE THE IMPLEMENTATION OF ACT 217, SESSION LAWS OF HAWAII 2018, REGARDING MISREPRESENTATION OF SERVICE ANIMALS.

WHEREAS, a service animal is an animal that is individually trained to work or perform tasks for a person with a disability; and

WHEREAS, the misrepresentation of pets and other nonservice animals as service animals diminishes the respect given to service animals and can create challenges for individuals who use the services of legitimate service animals; and

WHEREAS, Act 217, Session Laws of Hawaii 2018 (Act 217), established a civil penalty for knowingly misrepresenting an animal as a service animal; and

WHEREAS, the prohibition against misrepresentation of a service animal is placed in chapter 347, Hawaii Revised Statutes, which is administered by the Department of Human Services; and

WHEREAS, questions have arisen about Act 217, including the means to enforce the prohibition and the sufficiency of the language to address the issue; and

WHEREAS, guidance about misrepresentation of a service animal is needed to adequately inform law enforcement officers and the business community of the law; now, therefore,

BE IT RESOLVED by the House of Representatives of the Thirtieth Legislature of the State of Hawaii, Regular Session of 2019, the Senate concurring, that the Department of Human Services, in consultation with the Hawai'i Civil Rights Commission and the Disability and Communication Access Board, is

requested to examine and report on the implementation of Act 217, including:
