As required by HRS § 37-52.5(a), Section 3 of Act 166, Session Laws of Hawai'i 2016, the Judiciary respectfully submits this report to the Legislature of administratively established new accounts or funds.

Account No. S-19-246 The Hawai'i Innovations in Supervision (THIS) Initiative \$649,778.00

Justification for the establishment of the account or fund: To develop more effective and evidence-based probation and parole programs, which provides opportunities to increase community corrections agencies' ability to assist in reducing crimes committed by those supervised in the community.

Source of revenue: U. S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance

Account No. S-19-247 DWI Court, First Circuit, Honolulu, Hawai'i \$228,417.80

Justification: To continue a Driving While Impaired (DWI) Court projects in the District Court of the First Circuit. The project includes the establishment of coordination among the entities, the implementation of forms, documents and procedures, the maintenance of case management services, the security of DWI Court as a permanent budgetary fixture, the reduction of the recidivism and substance abuse amount participants, the establishment of an effect DWI Court Program, and the continuation of operating DWI Court Program.

Justification: To properly equip the Judiciary's Traffic Violations Bureau in the First Circuit and Second Circuit to continue to receive electronic citations and to enable the First Circuit Rural Courts to have access to the e-citation system, thereby reducing paper transport delays and increasing accuracy of data entry.

Account No. S-19-250 Judicial Education - Judicial Training \$53,327.00

Justification: To host statewide judicial training to increase knowledge about impaired driving and highway safety, as well as attendance at national conference.

Source of revenue: National Highway Traffic Safety Administration MAP-21 Section 402 program funds through the Hawai'i Department of Transportation

Account No. S-19-251 Judiciary Driver Education - Lifesavers \$8,000.00

Justification: To attend the Lifesavers National Conference on Highway Safety Priorities, which will provide the an opportunity to gather information regarding research, latest trends, programs, and best practices in combatting impaired driving, excessive speeding, and occupant protection. Source of revenue: National Highway Traffic Safety Administration FAST Act Section 402 program funds through the Hawai'i Department of Transportation

<u>Account No. S-19-252 Administrative Driver's License Revocation Office (ADLRO) – Training & Equipment Enhancement \$91,720.00</u>

Justification: To provide continuing education and specialized tools to enable Adjudicators to effectively manage the volume of OVUII hearings.
