A BILL FOR AN ACT

RELATING TO THE LICENSURE OF MIDWIVES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. As determined by Senate Concurrent Resolution
3	No. 64, S.D.1 (1998), subsequent Auditor's Report No. 99-14
4	(1999), House Concurrent Resolution No. 65, H.D.1 (2016), and
5	the subsequent Auditor's Report No. 17-01 (2017), the
6	legislature finds that it is necessary to establish a mandatory
7	regulatory process for the midwifery profession.
8	Hawaii regulated midwifery starting with registration in
9	1931, which progressed into certification and then licensure.
10	However, the regulation of midwifery was repealed in 1998 when
11	nurse-midwives were placed under the purview of the board of
12	nursing. Since 1998, there has been a lapse in regulation, yet
13	individuals in the community have continued to practice
14	midwifery and offer birth services to the public.
15	The legislature finds that mothers and families seek out
16	alternatives to hospital births and they find significant value
17	in community or home birth services. These services are

- 1 currently provided by individuals identifying themselves as
- 2 traditional or cultural practitioners, midwives, certified
- 3 professional midwives, lay midwives, direct entry midwives,
- 4 birth keepers, or birth attendants. This Act will continue to
- 5 allow a woman to choose where and with whom she gives birth.
- 6 The legislature further finds that the profession of
- 7 midwifery has continued to evolve since the lapse in regulation.
- 8 Common definitions, training, and competency standards for the
- 9 practice of midwifery have developed on both a global and
- 10 national level. However, not all practitioners easily fit into
- 11 these definitions, categories, and standards. Hawaii currently
- 12 has many individuals offering birth services under different
- 13 titles and at varying levels of competency and training.
- 14 The legislature further finds the term "midwife" connotes
- 15 an expectation of a minimum level of care by consumers and the
- 16 community. The Hawaii regulatory licensing reform act requires
- 17 the State to regulate professions or vocations where the health,
- 18 safety, or welfare of the consumer may be jeopardized by the
- 19 nature of the service offered by the provider. The practice of
- 20 midwifery meets these criteria, and, therefore, must be
- 21 regulated by the State.

1	The purpose of this Act is to resolve the lapse in
2	regulation of midwifery and to regulate midwives engaged in the
3	practice of midwifery by establishing licensure and regulatory
4	requirements under the department of commerce and consumer
5	affairs. This Act also exempts a separate category of birth
6	attendants for a three-year period, to allow this community to
7	define themselves and develop common standards, accountability
8	measures, and disclosure requirements. By the end of the three-
9	year period, the legislature intends to enact statutes that will
10	incorporate all birth practitioners and allow them to practice
11	to the fullest extent under the law. The legislature also notes
12	that practicing midwifery according to this Act does not impede
13	one's ability to incorporate or provide cultural practices.
14	SECTION 2. The Hawaii Revised Statutes is amended by
15	adding a new chapter to be appropriately designated and to read
16	as follows:
17	"CHAPTER

19	§ -1 Findings and purpose. The legislature finds that:

- 2 valid national certification as a certified midwife from the
- 3 American Midwifery Certification Board, or any successor
- 4 organization.
- 5 "Certified professional midwife" means a person who holds a
- 6 current and valid national certification as a certified
- 7 professional midwife from the North American Registry of
- 8 Midwives, or any successor organization.
- 9 "Client" means a person under the care of a licensed
- 10 midwife, as well as the person's fetus and newborn child.
- 11 "Department" means the department of commerce and consumer
- 12 affairs.
- "Director" means the director of commerce and consumer
- 14 affairs.
- 15 "International Confederation of Midwives" means the
- 16 accredited nongovernmental organization and representative of
- 17 midwives and midwifery to organizations worldwide to achieve
- 18 common goals in the care of mothers and newborns.
- "Interconception" means care provided to mothers between
- 20 pregnancies to improve health outcomes for women, newborns, and
- 21 children.

19	"Nor	th American Registry of Midwives" means the
20	organizat	ion that sets national standards for the certified
21	professio	onal midwife credential.

- 1 "Postpartum" means the period of time immediately after and
 2 up to eight weeks following the birth of the baby.
- 3 "Qualified midwife preceptor" means a licensed and
- 4 experienced midwife, or other maternal health professional
- 5 licensed in the State, who participates in the clinical
- 6 education of individuals enrolled in a midwifery education
- 7 program accredited by the Midwifery Education Accreditation
- 8 Council or Accreditation Commission For Midwifery Education and
- 9 who meets the criteria for midwife preceptors set forth by the
- 10 applicable organization.
- 11 § -3 Midwives licensing program. There is established a
- 12 midwives licensing program within the department to be
- 13 administered by the director.
- 14 § -4 Powers and duties of the director. In addition to
- 15 any other powers and duties authorized by law, the director
- 16 shall have the power and duties to:
- 17 (1) Grant permission to a person to use the title of
- 18 "midwife" or "licensed midwife" and engage in the
- 19 practice of midwifery in this State pursuant to this
- chapter and the rules adopted pursuant thereto;

1	(2)	Adopt, amend, or repeal rules pursuant to chapter 91
2		to carry out the purposes of this chapter;
3	(3)	Administer, coordinate, and enforce this chapter and
4		rules adopted pursuant thereto;
5	(4)	Discipline a licensee for any cause described by this
6		chapter or for any violation of rules or refuse to
7		license a person for failure to meet the licensing
8		requirements or for any cause that would be grounds
9		for disciplining a licensee;
10	(5)	Appoint an advisory committee to assist with the
11		implementation of this chapter and the rules adopted
12		pursuant thereto. The advisory committee shall
13		consist of the following:
14		(A) Three midwives who are certified professional
15		midwives or certified midwives;
16		(B) Two members of the public; and
17		(C) A certified nurse midwife; and
18	(6)	Add, remove, or otherwise modify the authorized non-
19		controlled legend drugs and legend devices listed in
20		-11 by rule under chapter 91.

- 1 § -5 License required. (a) Beginning July 1, 2020,
- 2 except as provided in this chapter, no person shall engage in
- 3 the practice of midwifery, or use the title "midwife", "licensed
- 4 midwife", or the abbreviation "L.M.", or any other words,
- 5 letters, abbreviations, or insignia indicating or implying that
- 6 the person is a licensed midwife without a valid license issued
- 7 pursuant to this chapter.
- 8 (b) Nothing in this section shall preclude a person
- 9 holding a national certification as a midwife from identifying
- 10 the person as holding such certification, so long as the person
- 11 is not practicing midwifery or professing to be authorized to
- 12 practice midwifery in the State unless that person is licensed
- in accordance with this chapter.
- 14 § -6 Exemptions. (a) A person may practice midwifery
- 15 without a license to practice midwifery if the person is:
- 16 (1) A certified nurse-midwife holding a valid license
- under chapter 457;
- 18 (2) Licensed and performing work within the scope of
- 19 practice or duties of the person's profession that
- 20 overlaps with the practice of midwifery;

2	nearest hospital if a problem arises during
3	the client's care; and
4	(D) Maintains a copy of the form required by
5	subparagraph (C) for at least ten years and makes
6	the form available for inspection upon request by
7	the department.
8	(b) Nothing in this chapter shall prohibit healing
9	practices by traditional Hawaiian healers engaged in traditional
10	healing practices of prenatal, maternal, and child care as
11	recognized by any council of kupuna convened by Papa Ola Lokahi.
12	Nothing in this chapter shall limit, alter, or otherwise
13	adversely impact the practice of traditional Native Hawaiian
14	healing pursuant to the Constitution of the State of Hawaii.
15	(c) Nothing in this chapter shall prohibit a person from
16	administering care to a person's spouse, domestic partner,
17	parent, sibling, or child.
18	§ -7 Fees. (a) Each applicant shall pay a licensing
19	fee upon application for an initial license or renewal of a
20	license. Fees collected pursuant to this section or by rule
21	adopted under this section shall be nonrefundable.

- 1 (b) Pursuant to section 26-9(1), the director may
- 2 establish fees to restore a license, penalty fees, and any other
- 3 fees required for the administration of this chapter by rule.
- 4 (c) All fees collected pursuant to this chapter shall be

- 6 resolution fund established pursuant to section 26-9(o).
- 7 (d) Fees assessed pursuant to this chapter shall be used
- 8 to defray costs incurred by the department in implementing this

4		(B) Certified midwife;
5	(4)	If applicable, evidence of any licenses held or once

9	(5)	Information regarding any conviction of any crime
10		which has not been annulled or expunged; and
11	(6)	Any other information the department may require to

15	license t	o any person who meets all licensure requirements and
16	pays the	appropriate fees.
17	S	-10 Renewals. Every license issued under this chapte:
18	shall be	renewed triennially on or before June 30, with the
19	first ren	ewal deadline occurring on June 30, 2023. Failure to
20	renew a 1	icense shall result in a forfeiture of the license

Licenses which have been so forfeited may be restored within one

21

- 1 year of the expiration date upon payment of renewal and penalty
- 2 fees. Failure to restore a forfeited license within one year of
- 3 the date of its expiration shall result in the automatic
- 4 termination of the license. Relicensure after termination shall
- 5 require the person to apply as a new applicant and again satisfy
- 6 all licensing requirements in place at the time of the new
- 7 application.
- 8 § -11 Authority to purchase and administer certain
- 9 legend drugs and devices. (a) A midwife licensed under this
- 10 chapter may purchase and administer non-controlled legend drugs
- 11 and devices that are used in pregnancy, birth, postpartum care,
- 12 newborn care, or resuscitation, and that are deemed integral to
- 13 providing care to the public by the department.
- (b) Legend drugs authorized under subsection (a) are
- 15 limited for:
- 16 (1) Neonatal use to prophylactic ophthalmic medications,
- 17 vitamin K, epinephrine for neonatal resuscitation per
- neonatal resuscitation guidelines, and oxygen; and
- 19 (2) Maternal use to antibiotics for Group B Streptococcal
- antibiotic prophylaxis per guidelines adopted by the
- 21 Centers for Disease Control and Prevention, postpartum

1		ancinemorinagics, Mio(b) immune grobuitin, epinephiline
2		for anaphylactic reaction to an administered

5	(c)	Legend devices authorized under subsection (a) are

1	condition	in any manner, any license for any one or more of the

4	(1)	Failing to meet or maintain the conditions and
5		requirements necessary to qualify for the granting of

12	(3)	Engaging in false, fraudulent, or deceptive
13		advertising, or making untruthful or improbable
14		statements;
15	(4)	Being addicted to, dependent on, or a habitual user of
16		a narcotic, barbiturate, amphetamine, hallucinogen,
17		opium, or cocaine, or other drugs or derivatives of a
18		similar nature;
19	(5)	Practicing as a licensed midwife while impaired by

alcohol, drugs, physical disability, or mental

instability;

1	(6)	Procuring a license through fraud, misrepresentation,
2		or deceit;
3	(7)	Aiding and abetting an unlicensed person to directly
4		or indirectly perform activities requiring a license;

7		incompetence, gross negligence, or manifest incapacity

19	(13)	Failing to comply, observe, or adhere to any law in a
20		manner such that the director deems the applicant or

1		licensee to be an unfit or improper person to hold a
2		license;
3	(14)	Having a revocation, suspension, or other disciplinary
4		action by a territory, or by another state or federal
5		agency against a licensee or applicant for any reason
6		provided by the licensing laws or this section;
7	(15)	Having a criminal conviction, whether by nolo
8		contendere or otherwise, of a penal crime directly
9		related to the qualifications, functions, or duties of
10		a licensed midwife;
11	(16)	Failing to report in writing to the director any
12		disciplinary decision issued against the licensee or
13		the applicant in another jurisdiction within thirty
14		days of the disciplinary decision;
15	(17)	Employing, utilizing, or attempting to employ or
16		utilize at any time any person not licensed under this
17		chapter where licensure is required;
18	(18)	Violating this chapter, any other applicable licensing
19		laws, or any rule or order of the director; or
20	(19)	Using or removing without authorization controlled
21		substances or drugs, including diverting or attempting

- 1 to divert drugs or controlled substances for
- 2 unauthorized use."
- 3 SECTION 3. Section 26H-4, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "§26H-4 Repeal dates for newly enacted professional and
- 6 vocational regulatory programs. (a) Any professional or
- 7 vocational regulatory program enacted after January 1, 1994, and
- 8 listed in this section shall be repealed as specified in this
- 9 section. The auditor shall perform an evaluation of the
- 10 program, pursuant to section 26H-5, prior to its repeal date.
- 11 (b) Chapter 465D (behavior analysts) shall be repealed on
- 12 June 30, 2021.
- (c) Chapter 466L (appraisal management companies) shall be
- 14 repealed on June 30, 2023.
- (d) Chapter (midwives) shall be repealed on June 30,
- **16** 2025."
- 17 SECTION 4. The department of commerce and consumer affairs
- 18 may appoint an executive officer and a secretary, without regard
- 19 to chapter 76, Hawaii Revised Statutes, to assist with the
- 20 activities of the midwives licensing program.

1	SECTION 5. The department of commerce and consumer affair		
2	may adopt interim rules to carry out the purposes of this Act		
3	without regard to chapters 91 or 201M, Hawaii Revised Statutes;		
4	provided that:		
5	(1) The department shall hold at least one public hearing		
6	prior to the adoption of interim rules; and		
7	(2) The interim rules shall be effective for no more than		
8	one year after their adoption.		
9	SECTION 6. There is appropriated out of the general		
10	revenues of the State of Hawaii the sum of \$146,000 or so much		
11	thereof as may be necessary for fiscal year 2019-2020 and the		
12	same sum or so much thereof as may be necessary for fiscal year		
13	2020-2021 to be deposited into the compliance resolution fund.		
14	SECTION 7. There is appropriated out of the compliance		
15	resolution fund the sum of \$73,000 or so much thereof as may be		
16	necessary for fiscal year 2019-2020 and the same sum or so much		
17	thereof as may be necessary for fiscal year 2020-2021 to		
18	implement the licensure of midwives as required by this Act.		
19	The sums appropriated shall be expended by the department		
20	of commerce and consumer affairs for the purposes of this Act.

3	force und	er the Hawaii state commission on the status of women.	
4	(b)	The task force shall consist of no more than twelve	
5	members and shall include:

9	(3)	A representative from the Hawaii section of the	
10		American College of Obstetricians and Gynecologists;

- 3 (e) The task force shall investigate issues relating to
- 4 direct entry midwives and home births. The investigation shall
- 5 include but not be limited to the following:
- 6 (1) Data collection and reporting on home births;
- 7 (2) Education and training of direct entry midwives; and
- **8** (3) Regulation of direct entry midwives.
- 9 (f) The members of the task force shall serve without
- 10 compensation. No member of the task force shall be made subject
- 11 to section 84-17, Hawaii Revised Statutes, solely because of
- 12 that member's participation on the task force. The task force
- 13 shall be exempt from chapter 92, Hawaii Revised Statutes.
- 14 (g) The Hawaii state commission on the status of women
- 15 shall provide administrative and clerical support required by
- 16 the task force.
- 17 (h) The task force shall submit a report of its findings
- 18 and recommendations, including any proposed legislation, to the
- 19 legislature no later than twenty days prior to the convening of
- 20 the regular session of 2020.

- 1 (i) The home birth task force shall dissolve on June 30,
- 2 2020.
- 3 PART III
- 4 SECTION 9. If any provision of this Act, or the
- 5 application thereof to any person or circumstance, is held
- 6 invalid, the invalidity does not affect other provisions or
- 7 applications of the Act that can be given effect without the
- 8 invalid provision or application, and to this end the provisions
- 9 of this Act are severable.
- 10 SECTION 10. This Act does not affect rights and duties
- 11 that matured, penalties that were incurred, and proceedings that
- 12 were begun before its effective date.
- 13 SECTION 11. New statutory material is underscored.
- 14 SECTION 12. This Act shall take effect upon its approval;
- 15 provided that sections 6 and 7 shall take effect on July 1,
- **16** 2019.
