## A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF TRANSPORTATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. On February 18, 2019, ongoing heavy rains
- 5 triggered landslides on the slopes adjacent to the Pali highway
- 6 in the city and county of Honolulu. On February 23, 2019, the
- 7 same weather system triggered landslides in the county of Maui,
- 8 causing extensive damage to the Honoapiilani highway, route 30.
- 9 Funding is critically needed to address both sites and remove
- 10 debris, inspect damage, scale slopes, remove additional
- 11 materials that are at risk of falling, and construct rockfall
- 12 protection structures for the public's safety.
- 13 The purpose of this Act is to make an emergency
- 14 appropriation to the department of transportation to mitigate
- 15 damages from the recent landslides on the Pali highway and
- 16 Honoapiilani highway and to prevent future landslides in both
- 17 locations, ensuring the safe mobility of people and goods.



- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$15,000,000 or so
- 3 much thereof as may be necessary for fiscal year 2018-2019 to
- 4 fund landslide recovery efforts for the Pali highway, including
- 5 maintenance of contraflow lanes, and the Honoapiilani highway,
- 6 including maintenance of limited access restrictions from mile
- 7 marker thirty-six to mile marker forty-two; and the construction
- 8 of landslide protective structures for both sites.
- 9 The sum appropriated shall be expended by the department of
- 10 transportation for the purposes of this Act.
- 11 SECTION 4. If the emergency relief projects funded by this
- 12 Act qualify for federal relief funds, for which the Federal
- 13 Highway Administration may reimburse up to eighty per cent of
- 14 the projects' cost upon their completion, then any amounts
- 15 received by the department of transportation from the Federal
- 16 Highway Administration as reimbursement for qualified federal
- 17 highway relief for the projects funded by this Act shall be
- 18 deposited into the general fund.
- 19 SECTION 5. The appropriation made for the emergency relief
- 20 projects authorized by this Act shall not lapse at the end of
- 21 the fiscal year for which the appropriation is made; provided

- 1 that all moneys from the appropriation unencumbered as of June
- 2 30, 2020, shall lapse as of that date.
- 3 SECTION 6. This Act shall take effect on July 1, 2050.
