
A BILL FOR AN ACT

RELATING TO THE SALE OF TOBACCO PRODUCTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 712-1258, Hawaii Revised Statutes, is
2 amended by amending subsections (6) and (7) to read as follows:
- 3 "(6) Any employee of a retailer, permittee, or registrant
4 who violates subsection (1) or (4), or both, shall be fined \$100
5 for the first offense, and not less than \$100 nor more than \$500
6 for any subsequent offense within five years of a previous
7 offense. Any ~~[person who]~~ retailer, permittee, or registrant
8 who violates or whose employee violates subsection (1) or (4),
9 or both, shall [be]:
- 10 (a) Be fined \$500 for the first offense ~~[- Any subsequent~~
11 ~~offenses shall subject the person to a fine not less~~
12 ~~than \$500 nor more than \$2,000-];~~
- 13 (b) Be fined not less than \$500 nor more than \$5,000 for a
14 second offense within five years of a previous
15 offense; and



1 (c) Have the retailer's, permittee's, or registrant's
2 license suspended for a third or any subsequent
3 offense within five years of the last offense.

4 Any person under twenty-one years of age who violates subsection
5 (5) shall be fined \$10 for the first offense. Any subsequent
6 offense shall subject the violator to a fine of \$50, no part of
7 which shall be suspended, or the person shall be required to
8 perform not less than forty-eight hours nor more than seventy-
9 two hours of community service during hours when the person is
10 not employed and is not attending school. Any tobacco product
11 or electronic smoking device, as those terms are defined in
12 subsection (7), in the person's possession at the time of
13 violation of subsection (5) shall be seized, summarily forfeited
14 to the State, and destroyed by law enforcement following the
15 conclusion of an administrative or judicial proceeding finding
16 that a violation of subsection (5) has been committed. The
17 procedures set forth in chapter 712A shall not apply to this
18 subsection.

19 (7) For the purposes of this section:

20 "Electronic smoking device" means any electronic product
21 that can be used to aerosolize and deliver nicotine or other



1 substances to the person inhaling from the device, including but
2 not limited to an electronic cigarette, electronic cigar,
3 electronic cigarillo, or electronic pipe, and any cartridge or
4 other component of the device or related product.

5 "Permittee" means the holder of a retail tobacco permit in
6 accordance with chapter 245.

7 "Registrant" means an entity registered with the electronic
8 smoking device retailer registration unit pursuant to section
9 28-164.

10 "Retailer" means an entity that engages in the practice of
11 selling cigarettes or tobacco products to consumers and includes
12 the owner of a cigarette or tobacco product vending machine.

13 "Tobacco product" means any product made or derived from
14 tobacco that contains nicotine or other substances and is
15 intended for human consumption or is likely to be consumed,
16 whether smoked, heated, chewed, absorbed, dissolved, inhaled, or
17 ingested by other means. "Tobacco product" includes but is not
18 limited to a cigarette, cigar, pipe tobacco, chewing tobacco,
19 snuff, snus, or an electronic smoking device. "Tobacco product"
20 does not include drugs, devices, or combination products
21 approved for sale by the United States Food and Drug



1 Administration, as those terms are defined in the Federal Food,
2 Drug, and Cosmetic Act."

3 SECTION 2. This Act does not affect rights and duties that
4 matured, penalties that were incurred, and proceedings that were
5 begun before its effective date.

6 SECTION 3. Statutory material to be repealed is bracketed
7 and stricken. New statutory material is underscored.

8 SECTION 4. This Act shall take effect on July 1, 2050.
