BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTI	ION 1. Chapter 804, Hawaii Revised Statutes, is	
2	amended by	adding a new section to be appropriately designated

4	" <u>§</u> 804	Unsecured bail. (a) After an amount of bail is	
5	determined	d by a justice or judge pursuant to section 804-9, a	
6	defendant	in custody may petition the court for unsecured bail.	
7	Upon a sho	owing that:	
8	(1)	Securing the bail bond or obtaining a surety or	
9		sureties to secure the bail bond pursuant to section	
10		804-11.5 would result in significant financial	
11		hardship; and	
12	(2)	The continued incarceration of the defendant would	
13		jeopardize the defendant's ability to maintain	
14		employment, remain enrolled in any educational or	
15		training program, care for a dependent, continue	
16		medical or therapeutic treatment, or maintain housing;

1	the court may order the defendant released upon the execution of
2	an unsecured financial bond for all or part of the bail amount
3	by the defendant and any additional obligors as may be required
4	by the court, upon the deposit of cash or other security as
5	described in section 804-11.5 for any remaining bail amount not
6	covered by the unsecured financial bond, and subject to any
7	other conditions of release that will reasonably assure the
8	appearance of the defendant in court as required and protect the
9	<pre>public.</pre>
10	(b) In the event that a defendant fails to appear in court
11	as required or breaches any other condition of release, the
12	court shall take appropriate steps to collect the amount of the
13	unsecured financial bond from the defendant or any additional
14	obligors originally required by the court.
15	(c) In granting or denying a petition for unsecured bail,
16	the court may consider:
17	(1) The defendant's:
18	(A) Employment status and history;
19	(B) Family relationships, specifically the nature and
20	extent of those relationships;
21	(C) Past and present residences;

1		(D) Character and reputation;
2		(E) Ties to the community;
3		(F) Financial circumstances; and
4		(G) Prior criminal record, if any, and any prior
5		failures to appear in court;
6	(2)	The agreement of any person to assist the defendant to
7		appear in court when required and to satisfy the
8		conditions of release;
9	(3)	The results of an empirical and validated pretrial
10		risk assessment;
11	(4)	The offense charged and any potential sentence; and
12	<u>(5)</u>	Any other facts the court finds relevant to the
13		defendant's likelihood to appear in court and satisfy
14		the conditions of release."
15	SECT	ION 2. This Act does not affect rights and duties that
16	matured,	penalties that were incurred, and proceedings that were
17	begun bef	ore its effective date.
18	SECT	ION 3. New statutory material is underscored.
19	SECT	ION 4. This Act shall take effect on July 1, 2050.
