
A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are established within the department of
3 public safety twenty-three full-time equivalent (23.00 FTE)
4 permanent staff positions for the women's community correctional
5 center hookipa makai cottage (PSD409/EK).

6 SECTION 2. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$1,424,678 or so much
8 thereof as may be necessary for fiscal year 2020-2021 for the
9 women's community correctional center hookipa makai cottage
10 (PSD409/EK).

11 The sum appropriated shall be expended by the department of
12 public safety for the purposes of this Act.

13 PART II

14 SECTION 3. There is appropriated out of the general
15 revenues of the State of Hawaii the sum of \$4,285,307 or so much
16 thereof as may be necessary for fiscal year 2019-2020 to finance
17 six additional months of housing costs, from July 1, 2019, to



1 SECTION 6. There are established within the department of
2 public safety thirty-one full-time equivalent (31.00 FTE) adult
3 correctional officer positions at Halawa correctional facility
4 (PSD402), Waiawa correctional facility (PSD404), Maui community
5 correctional center (PSD406), Oahu community correctional center
6 (PSD407), and general administration (PSD900).

7 SECTION 7. There is appropriated out of the general
8 revenues of the State of Hawaii the sum of \$1,825,644 or so much
9 thereof as may be necessary for fiscal year 2019-2020 and the
10 same sum or so much thereof as may be necessary for fiscal year
11 2020-2021 for thirty-one adult correctional officer positions at
12 Halawa correctional facility, Waiawa correctional facility, Maui
13 community correctional center, and Oahu community correctional
14 center (PSD402, PSD404, PSD406, PSD407, PSD900).

15 The sums appropriated shall be expended by the department
16 of public safety for the purposes of this Act.
