A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has not
- 2 developed a plan to transition its agriculture industry, once
- 3 dominated by sugar and pineapple, to an industry that is
- 4 beneficial for diversified food crops. While diversified
- 5 agriculture has increased, industry experts estimate that Hawaii
- 6 imports approximately eighty-five to ninety per cent of the food
- 7 that it consumes.
- **8** According to a report issued in October 2012 by the office
- 9 of planning in cooperation with the department of agriculture,
- 10 entitled "Increased Food Security and Food Self-Sufficiency
- 11 Strategy: A State Strategic/Functional Plan Prepared in
- 12 Accordance with HRS Chapter 226 Hawaii State Plan and the Hawaii
- 13 Comprehensive Economic Development Strategy", replacing just ten
- 14 per cent of the food that Hawaii currently imports would retain
- 15 approximately \$313,000,000 in the State and generate more than
- 16 two thousand three hundred jobs. Investing in farmland and

- 1 irrigation infrastructure will bring Hawaii closer to self-
- 2 sufficiency, and local investments will benefit local residents.
- 3 The legislature further finds that the governor has set the
- 4 policy goal of doubling Hawaii's food production by 2020.
- 5 However, details on how to achieve this objective have yet to be
- 6 identified. Issues such as preserving agricultural land,
- 7 identifying food crops for local production, and improving
- 8 irrigation and agricultural infrastructure need immediate
- 9 attention so that doubling food production can become a
- 10 realistic objective. Implications of the federal FDA Food
- 11 Safety Modernization Act, which will have significant effects on
- 12 local agriculture, must also be addressed. Due to the need to
- 13 address multiple issues in order to double local food production
- 14 and with 2020 less than one year away, this Act sets the goal of
- 15 doubling local food production by 2030.
- 16 The purpose of this Act is to require the department of
- 17 agriculture, in cooperation with the office of the governor, to
- 18 develop a strategic plan to achieve the governor's goal of
- 19 doubling food production and increasing food exports by 2030.
- 20 SECTION 2. (a) The department of agriculture, in
- 21 cooperation with the office of the governor, shall establish a

1	strategic	plan that identifies benchmarks for increased food
2	production	n in Hawaii and increased exports of food crops and
3	value-add	ed agricultural products from Hawaii.
4	(b)	The strategic plan shall identify benchmarks that are
5	quantitat	ively and qualitatively measurable and the metrics to
6	determine	progress toward the following goals:
7	(1)	Doubling local food production and exports by 2030;
8	(2)	Identifying food crops that may be grown locally to
9		replace imports and increase exports of food crops and
10		value-added agricultural products from Hawaii;
11	(3)	Identifying lands for:
12		(A) Producing food crops that may be grown locally to
13		replace imports;
14		(B) Raising livestock; and
15		(C) Developing value-added agricultural products;
16	(4)	Developing guidance for decisions regarding land
17		acquisition, irrigation, and agricultural
18		infrastructure; and
19	(5)	Identifying implications and effects of the federal
20		FDA Food Safety and Modernization Act on local food

production and export.

- 1 (c) The department of agriculture shall submit the
- 2 strategic plan, including proposed strategies, benchmarks,
- 3 metrics, and any proposed legislation, to the legislature no
- 4 later than twenty days prior to the convening of the regular
- 5 session of 2020.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$ or so much
- 8 thereof as may be necessary for fiscal year 2019-2020 for the
- 9 purpose of developing a strategic plan outlining strategies,
- 10 benchmarks, and metrics to achieve the goal of doubling food
- 11 production in, and increasing food exports out of the State by
- **12** 2030.
- 13 The sum appropriated shall be expended by the department of
- 14 agriculture for the purposes of this Act.
- 15 SECTION 4. This Act shall take effect on July 1, 2150.
