A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in order for
- 2 nonprofit organizations to effectively work in concert with
- 3 state and county governments, these organizations require a
- 4 clear understanding of the state procurement system, including
- 5 the proposal and bid processes, to most effectively offer
- 6 homeless outreach services or manage homeless housing programs.
- 7 The legislature further finds that while these types of programs
- 8 are robust in urban areas, homeless outreach services and
- 9 homeless housing programs are lacking in rural areas of the
- 10 State.
- Accordingly, the purpose of this Act is to require the
- 12 department of human services and state procurement office to
- 13 establish a program to provide training on government
- 14 procurement and other relevant procedures to nonprofit
- 15 organizations that offer homeless outreach services or manage
- 16 homeless housing programs in rural areas of the State.

- 1 SECTION 2. (a) The department of human services, in
- 2 partnership with the state procurement office, shall establish
- 3 and implement a training program on government procurement and
- 4 other relevant procedures for nonprofit organizations that offer
- 5 homeless outreach services or manage homeless housing programs
- 6 in rural areas of the State.
- 7 (b) The department of human services shall adopt rules
- 8 pursuant to chapter 91, Hawaii Revised Statutes, to effectuate
- 9 the purposes of this section.
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$270,000 or so much
- 12 thereof as may be necessary for fiscal year 2019-2020 and the
- 13 same sum or so much thereof as may be necessary for fiscal year
- 14 2020-2021 to establish and implement a training program for
- 15 nonprofit organizations that offer homeless outreach services or
- 16 manage homeless housing programs in rural areas of the State.
- 17 The sums appropriated shall be expended by the state
- 18 procurement office for the purposes of this Act.
- 19 SECTION 4. This Act shall take effect on July 1, 2019.
