# A BILL FOR AN ACT

RELATING TO PRESCRIPTIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 329-38, Hawaii Revised Statutes, is
2	amended b	y amending subsections (b) and (c) to read as follows:
3	"(b)	A schedule II controlled substance prescription
4	shall:	
5	(1)	Be filled within seven days following the date the
6		prescription was issued to the patient; and
7	(2)	Be supplied to a patient only if the prescription has
8		been filled and held by the pharmacy for not more than
9		seven days [+]; provided that a prescription issued to
10		a qualifying patient pursuant to chapter 327L shall be
11		supplied to the patient if the prescription has been
12		filled and held by the pharmacy for not more than
13		thirty days.
14	(c)	Initial concurrent prescriptions for opioids and
15	benzodiaz	epines shall not be for longer than seven consecutive
16	days unle	ss the prescription is issued for a qualifying patient

pursuant to chapter 327L or a supply of longer than seven days 1 is determined to be medically necessary for the treatment of: 2 Pain experienced while the patient is in post-3 (1) operative care; 4 Chronic pain and pain management; 5 (2) Substance abuse or opioid or opiate dependence; (3) 6 Cancer; 7 (4)Pain experienced while the patient is in palliative 8 (5) care; or 9 Pain experienced while the patient is in hospice care; 10 (6) provided that if a prescribing practitioner issues a concurrent 11 prescription for more than a seven-day supply of an opioid and 12 benzodiazepine, the practitioner shall document in the patient's 13 medical record the condition for which the practitioner issued 14 the prescription and that an alternative to the opioid and 15 benzodiazepine was not appropriate treatment for the condition." 16 SECTION 2. - 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect on July 1, 2050;
- 9 provided that the amendments made to section 329-38, Hawaii
- 10 Revised Statutes, by section 1 of this Act shall not be repealed
- 11 when that section is repealed and reenacted pursuant to Act 66,
- 12 Session Laws of Hawaii 2017.

#### Report Title:

Our Care, Our Choice; Opioids; Prescriptions

### Description:

Clarifies that existing law intended to curb over-access to and abuse of opioids, including the time frame for filling prescriptions, supply limitations, and requirements to check the state electronic prescription accountability system and execute an informed consent process, do not apply to qualifying patients who are prescribed or issued prescriptions pursuant to the State's Our Care, Our Choice Act. (SB536 HD1)
