## A BILL FOR AN ACT

RELATING TO FUEL CELL ELECTRIC VEHICLES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTI	ON 1. Section 103D-412, Hawaii Revised Statutes, is
2	amended by	amending subsections (b) and (c) to read as follows:
3	"(b)	Beginning January 1, 2010, all state and county
4	entities,	when purchasing new vehicles, shall seek vehicles with
5	reduced de	pendence on petroleum-based fuels that meet the needs
6	of the age	ncy. Priority for selecting vehicles shall be as
7	follows:	
8	(1)	Electric or plug-in hybrid electric vehicles[+] and
9		fuel cell electric vehicles;
10	[ <del>(2)</del>	Hydrogen or fuel cell vehicles;
11	<del>(3)</del> ]	(2) Other alternative fuel vehicles;
12	[ <del>(4)</del> ]	(3) Hybrid electric vehicles; and
13	[ <del>(5)</del> ]	(4) Vehicles that are identified by the United States
14		Environmental Protection Agency in its annual "Fuel
15		Economy Leaders" report as being among the top
16		performers for fuel economy in their class.
17	(c)	For the purposes of this section:

- 1 "Agency" means a state agency, office, or department.
- 2 "Alternative fuel" means alcohol fuels, mixtures containing
- 3 eighty-five per cent or more by volume of alcohols with gasoline
- 4 or other fuels, natural gas, liquefied petroleum gas, hydrogen,
- 5 biodiesel, mixtures containing twenty per cent or more by volume
- 6 of biodiesel with diesel or other fuels, other fuels derived
- 7 from biological materials, and electricity provided by off-board
- 8 energy sources.
- 9 "Covered fleet" has the same meaning as contained in 10
- 10 Code of Federal Regulations Part 490 Subpart C.
- 11 "Excluded vehicles" has the same meaning as provided in 10
- 12 Code of Federal Regulations section 490.3.
- 13 "Fuel cell electric vehicle" means a zero-emission electric
- 14 vehicle that uses a fuel cell to convert hydrogen gas and oxygen
- 15 into electricity that is used in a vehicle powertrain for
- 16 propulsion.
- "Light-duty motor vehicle" has the same meaning as
- 18 contained in 10 Code of Federal Regulations Part 490, not
- 19 including any vehicle incapable of traveling on highways or any
- 20 vehicle with a gross vehicle weight rating greater than eight
- 21 thousand five hundred pounds."

13	"Ele	ctric vehicle charging system" means a system that:
14	(1)	Is capable of providing electricity from a non-vehicle
15		source to charge the batteries of one or more electric
16		vehicles;
17	(2)	Meets recognized standards, including standard SAE
18		J1772 of SAE International; and
19	(3)	Is designed and installed in compliance with article
20		625 of the National Electrical Code[-];

- 1 provided that the term shall not include facilities or systems 2 for refueling the hydrogen storage tank of a fuel cell electric 3 vehicle. 4 "Fuel cell electric vehicle" means a zero-emission electric 5 vehicle that uses a fuel cell to convert hydrogen gas and oxygen 6 into electricity that is used in a vehicle powertrain for 7 propulsion. 8 "Place of public accommodation" has the same meaning as 9 that provided in section 489-2." 10 SECTION 3. Act 168, Session Laws of Hawaii 2012, is 11 amended by amending subsection (d) of section 2 to read as 12 follows: 13 "(d) For the purposes of this Act: 14 "Electric vehicle" means: 15 (1) A neighborhood electric vehicle; [or] 16 (2) A vehicle, with four or more wheels, that draws 17 propulsion energy from a battery with at least four 18 kilowatt hours of energy storage capacity that can be 19 recharged from an external source of electricity [-]; 20 or

- 7 SECTION 5. This Act shall take effect on July 1, 2100.
