Your Committee reviewed the personal history, resume, and statement submitted by Suzie Nemmers, M.D., for service on the Medical Advisory Board.

Your Committee received testimony in support of the nomination for the appointment of Suzie Nemmers, M.D., from the Department of Transportation.

Upon review of the testimony, your Committee finds that Dr. Nemmers is a physician and surgeon in the Department of Ophthalmology at Tripler Army Medical Center. She is a member of the American Medical Association, Hawaii Ophthalmology Society, American Academy of Ophthalmology and American Society of Cataract and Refractive Surgery.
