Your Committee on Health, to which was referred H.B. No. 140
entitled:

"A BILL FOR AN ACT RELATING TO HEALTH,"

begs leave to report as follows:

The purpose of this bill is to effectuate its title.

H.B. No. 140 was introduced as a short-form bill, which is
sometimes referred to as a "vehicle" bill primarily used to
introduce a bill containing only a general idea as to the purpose
of the bill without specific details in the long form.

Your Committee has amended the bill to provide the
substantive contents of the bill in long form so that a public
hearing may be properly held on its substantive contents.

The purpose of this measure, as amended, is to encourage
postgraduate medical students practicing as resident or fellow
physicians to participate in the peer-review process by granting
them the same protections afforded to licensed physicians engaging
in effective peer-review.

No testimony was submitted for this measure.
