The purpose of this measure is to support best practices for an effective correctional system by:

- (1) Establishing the Hawaii Correctional System Oversight Commission; and
- (2) Consolidating the Reentry Commission and Corrections
  Population Management Commission into the Hawaii
  Correctional System Oversight Commission and
  transferring the rights, powers, functions, and duties
  of the consolidated commissions to the Hawaii
  Correctional System Oversight Commission.

The Department of Public Safety, Office of Hawaiian Affairs, O'ahu County Committee on Legislative Priorities of the Democratic Party of Hawai'i, Ho'omana Pono, LLC, and several individuals supported this measure. The Hawaii Paroling Authority, Civil Beat Law Center for the Public Interest, and Community Alliance on Prisons provided comments.

Your Committee has amended this measure by changing the effective date to January 28, 2081, to encourage further discussion.

No. 1552, H.D. 1, as amended herein, and recommends that it be referred to your Committee on Finance in the form attached hereto as H.B. No. 1552, H.D. 2.
