Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 66, H.D. 1, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO ATHLETE AGENTS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to repeal the existing Uniform Athlete Agents Act (Uniform Act) and replace it with the Revised Uniform Athlete Agents Act, which applies to certain financial advisers and makes other changes to the Uniform Act to increase effectiveness and enforceability.

Your Committee on Conference has amended this measure by changing its effective date to July 1, 2020.



As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of H.B. 


