Your Committee on Labor & Public Employment, to which was referred H.B. No. 941 entitled:

"A BILL FOR AN ACT RELATING TO EMPLOYEE'S DESIGNATION OF BENEFICIARY FORM,"

begs leave to report as follows:

The purpose of this measure is to permit:

- (1) An employee's designation of beneficiary form to be kept in the department where the employee is employed; and
- (2) Employees' designation of beneficiary information to be filed and maintained electronically.

The Department of Accounting and General Services testified in support of this measure.

Your Committee has amended this measure by changing its effective date to January 1, 2050, to facilitate further discussion.

As affirmed by the record of votes of the members of your Committee on Labor & Public Employment that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 941, as amended herein, and recommends that it pass


