Your Committee on Ways and Means, to which was referred
H.C.R. No. 82 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE DEPARTMENT OF
BUDGET AND FINANCE TO CONDUCT A STUDY ON THE FEASIBILITY OF
CREATING A PROGRAM THAT WOULD ALLOW QUALIFIED INDIVIDUALS TO
REMIT VEHICLE REGISTRATION FEES ON A BIANNUAL BASIS,"

begs leave to report as follows:

The purpose and intent of this measure is to request that the
Department of Budget and Finance conduct a study on the
feasibility of creating a program that would allow qualified
individuals to remit registration fees on a biannual basis.

For the purposes of a public hearing, your Committee
circulated a proposed S.D. 1 (Proposed Draft) of the measure and
notified the public that your Committee would be accepting
testimony on the Proposed Draft, which deletes the title and
contents of the measure and inserts provisions that request the
Department of Transportation, City and County of Honolulu, Ewa
Beach Golf Course, Carmel Partners, Iroquois Point, and Ewa Beach
Neighborhood Board to form a task force regarding the management
of North Road.

Your Committee received testimony in support of the Proposed
Draft from the Department of Transportation.




Your Committee finds that safety improvements and the unified management of North Road may be necessary to address the issues affecting North Road, including illegal dumping and a lack of regular maintenance and repairs on the road.

Your Committee has amended this measure by adopting the Proposed Draft.


