"A BILL FOR AN ACT RELATING TO PROCUREMENT FILING FEE,"

begs leave to report as follows:

The purpose of this measure is to provide a funding mechanism to partially cover the costs to conduct procurement bid challenge hearings by requiring a party initiating a bid challenge to pay the Department of Commerce and Consumer Affairs (DCCA) a nonrefundable filing fee for contracts with an estimated value of \$500,000 or more.

DCCA testified in support of this measure. The General Contractors Association of Hawaii testified in opposition to this measure. The State Procurement Office provided comments on this measure.

Your Committee has amended this measure by:

- (1) Changing its effective date to January 1, 2050, to facilitate further discussion on this measure; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.
