Your Committee on Lower & Higher Education, to which was referred S.B. No. 12, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO TEACHER HOUSING,"

begs leave to report as follows:

The purpose of this measure is to provide full-time teachers at hard-to-fill public schools, including public charter schools, with housing vouchers for rent or mortgage payments for the teacher's primary residence.

The Office of Hawaiian Affairs, Hawaii State Teachers Association, Democratic Party of Hawai'i Education Caucus, Hawai'i Association of REALTORS, and two individuals submitted testimony in support of this measure. The Department of Education submitted comments on this measure.

Your Committee has amended this measure by changing its effective date to July 1, 2052, to promote further discussion.


