Your Committee on Higher Education, to which was referred
S.B. No. 1419 entitled:

"A BILL FOR AN ACT RELATING TO THE UNIVERSITY OF HAWAII,"

begs leave to report as follows:

The purpose and intent of this measure is to require the
University of Hawaii to include all long-term leases the
university enters into with the intent to purchase as part of its
capital improvement projects budget request.

Your Committee received comments on this measure from the
University of Hawai'i System.

Your Committee finds that the funds expended by the
University of Hawaii and the accompanying contractual obligations
it must adhere to when entering into long-term leases are matters
of statewide concern. This measure provides additional
transparency for the potential purchasing of property by the
University of Hawaii to ensure that university resources are used
effectively and efficiently.

Your Committee has amended this measure by making technical,
nonsubstantive amendments for the purposes of clarity and
consistency.
