The University of Hawaii System submitted testimony in support of this measure. The Department of Education, Democratic Party of Hawai'i Education Caucus, and Kamehameha Schools submitted comments on this measure.

Your Committee has amended this measure by:

 Clarifying that the University of Hawaii is required to submit an annual report to the Legislature no later than thirty days prior to the convening of the Regular Session of 2021 and each Regular Session thereafter;

- (2) Changing the appropriation amount for additional funds for the Hawaii Community College Promise Program from \$800,000 to \$700,000;
- (3) Changing the effective date to July 1, 2019; and
- (4) Making technical, nonsubstantive amendments for clarity, consistency, and style.
