Your Committee on Ways and Means, to which was referred
S.C.R. No. 115 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE GOVERNOR TO
PRIORITIZE THE PLANTING OF FOUR MILLION TREES ALONG STREETS
AND ROADWAYS WITHIN THE NEXT FOUR YEARS TO HELP ADDRESS
CLIMATE CHANGE AND MAKE COMPLETE STREETS STATEWIDE,"

begs leave to report as follows:

The purpose and intent of this measure is to request the
Governor to prioritize the planting of four million trees along
streets and roadways within the next four years.

Your Committee received written comments in support of this
measure from the Department of Land and Natural Resources and five
concerned individuals.

Your Committee finds that planting additional trees along
streets and roadways will help to make streets safer by slowing
traffic, and will reduce urban heat, reduce stormwater runoff and
erosion, improve air quality, and sequester additional carbon
dioxide from the atmosphere.

As affirmed by the record of votes of the members of your
Committee on Ways and Means that is attached to this report, your
Committee concurs with the intent and purpose of S.C.R. No. 115
and recommends its adoption.
