The purpose and intent of this measure is to urge the
Department of Land and Natural Resources' Division of Forestry and
Wildlife to document the history of exemplary contributions made
by community members, including kupuna, conservationists, and
citizens.

Your Committee received testimony in support of this measure
from the O'ahu County Democrats and O'ahu County Democrats
Committee on Legislative Priorities. Your Committee received
comments on this measure from the Department of Land and Natural


