Your Committee on Ways and Means, to which was referred
S.C.R. No. 164 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE AMENDMENT OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE
SUBMERGED LANDS AT SPRECKELSVILLE, WAILUKU, MAUI, FOR THE
EXISTING SEAWALL AND BOULDER REVETMENT AND FOR USE, REPAIR,
AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED
THEREON, "

begs leave to report as follows:

The purpose and intent of this measure is to grant
legislative approval to amend an easement for a portion of state
submerged lands located seaward of Spreckelsville, Wailuku, Maui.

Your Committee received written comments in support of this
measure from the Department of Land and Natural Resources.


Your Committee finds that section 171-53, Hawaii Revised
Statutes, requires the Board of Land and Natural Resources to
obtain authorization from the Legislature to dispose of state
submerged lands. The Board has increased the area of a previously
issued easement on the property identified as Tax Map Key:
(2) 3-8-002: seaward of 001, from 1,128 square feet, more or
less, to 2,206 square feet, more or less, based on a finalized
easement map. Your Committee further finds that this measure
expresses the requisite legislative approval so that the existing
easement may be amended to include this area. Your Committee



notes that the grantee will be required to pay the State the fair market value of the easement as consideration for the use of public lands.

As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 164 and recommends its adoption.


