Sir:

Your Committee on Ways and Means, to which was referred  
S.C.R. No. 183 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF  
TERM, NON-EXCLUSIVE EASEMENTS COVERING PORTIONS OF STATE  
SUBMERGED LANDS AT WAIOHULI-KEOKEA (KIHEI), WAILUKU, MAUI,  
HAWAII, FOR THE USE, MAINTENANCE, AND REPAIR OF THE EXISTING  
SEAWALL CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the  
Board of Land and Natural Resources to issue term, non-exclusive  
easements covering a portion of state submerged lands identified  
as Tax Map Key: (2) 3-9-11:8, situated at Waiohuli-Keokea (Kihei),  
Wailuku, Maui, Hawaii, for the use, maintenance, and repair of the  
existing seawall constructed thereon.

Your Committee received testimony in support of this measure  
from the Department of Land and Natural Resources.

Your Committee finds that section 171-53, Hawaii Revised  
Statutes, requires the prior approval of the Governor and prior  
authorization of the Legislature by concurrent resolution for this  
disposition of state submerged lands.

Your Committee also finds that on August 25, 2017, under  
agenda item D-9, and on October 12, 2018, under agenda item D-5,  
the Board of Land and Natural Resources approved the issuance of



term, non-exclusive easements to resolve the encroachments of the existing seawall areas identified in this measure.

As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 183 and recommends its adoption.


