Your Committee on Education, to which was referred S.C.R. No. 187 entitled:

"SENATE CONCURRENT RESOLUTION URGING THE DEPARTMENT OF EDUCATION TO ADOPT THE USE OF ELECTRONIC TRANSCRIPTS,"

The purpose and intent of this measure is to urge the Department of Education to adopt the use of electronic transcripts.


