"SENATE CONCURRENT RESOLUTION URGING THE BOARD OF LAND AND
NATURAL RESOURCES TO TRANSFER MANAGEMENT OF ALL SUBMERGED
LANDS, THE BOAT LAUNCH RAMP, AND ANY RELATED BOAT LAUNCH RAMP
FACILITIES LOCATED AT THE WAHIAWA FRESHWATER STATE RECREATION
AREA FROM THE DIVISION OF AQUATIC RESOURCES TO THE DIVISION

begs leave to report as follows:

The purpose and intent of this measure is to promote the
efficient management of the State's submerged lands and aquatic
recreational facilities.

Specifically, this measure urges the Board of Land and
Natural Resources to transfer management of all submerged lands,
the boat launch ramp, and any related boat launch ramp facilities
located at the Wahiawa Freshwater State Recreation Area from the
Division of Aquatic Resources to the Division of Boating and Ocean
Recreation.

Your Committee received written comments in support of this
measure from the Department of Land and Natural Resources.

Your Committee finds that the Division of Boating and Ocean
Recreation of the Department of Land and Natural Resources could


