S.C.R. No. 72, S.D. 1, entitled:

"SENATE CONCURRENT RESOLUTION URGING THE COUNTIES TO SUBMIT A  
REPORT TO THE LEGISLATURE ON HOW MANY VEHICLE WEIGHT TAX  
EXEMPTIONS ARE CLAIMED BY MEMBERS OF THE NATIONAL GUARD,  
MILITARY RESERVES, AND OTHER ARMED SERVICES,"

The purpose and intent of this measure is to urge the  
counties to submit a report to the Legislature regarding use of  
vehicle weight tax exemptions by members of the armed services.

No written comments were received on this measure.

Your Committee finds that, due to the limited ability of the  
State to determine the number of members of the armed services who  
claim vehicle weight tax exemptions and who also claim residency  
in the State, the counties may be the most appropriate entities to  
provide this information.

As affirmed by the record of votes of the members of your  
Committee on Ways and Means that is attached to this report, your  
Committee concurs with the intent and purpose of S.C.R. No. 72,  
S.D. 1, and recommends its adoption.


