Your Committee on Commerce, Consumer Protection, and Health,  
to which was referred S.C.R. No. 91 entitled:

"SENATE CONCURRENT RESOLUTION RECOGNIZING THE IMPORTANCE OF  
AN ADDITIONAL AMBULANCE TO SERVE RESIDENTS IN THE MAKALEI  
AREA, KAILUA-KONA, ISLAND OF HAWAII,"

begs leave to report as follows:

The purpose and intent of this measure is to recognize the  
importance of an additional ambulance to serve residents in the  
Makalei area, Kailua-Kona, Island of Hawaii.

Your Committee received testimony in support of this measure  
from the Hawai'i County Council.

Your Committee finds the population of the Makalei area of  
Kailua-Kona, on the Island of Hawaii, has increased significantly  
over the years. However, primary care services are as far as  
thirty miles away from the area and can be challenging for the  
community to access because of distance, transportation issues,  
and economic challenges. As a result, the Makalei community  
relies heavily on emergency medical services. Your Committee  
recognizes that a new advanced life support ambulance to serve the  
Makalei area of Kailua-Kona will strengthen the existing emergency  
services infrastructure, which will improve health outcomes among  
residents and visitors in Kailua-Kona.



As affirmed by the record of votes of the members of your Committee on Commerce, Consumer Protection, and Health that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 91 and recommends that it be referred to your Committee on Ways and Means.
