Your Committee received testimony in support of this measure from one individual.



Your Committee further finds that improving access to and increasing the availability of sustainable local foods will benefit the residents of Hawaii and the State as a whole. This measure therefore requests the Department of Agriculture, in consultation with various stakeholders, to develop a Sustainable Food Security Strategic Plan and report its findings to the Legislature.
